ORDINANCE NO. 99-049

AN ORDINANCE GRANTING INCENTIVE FOR THE YEAR 1999 OF ONE SACK OF RICE TO EACH EMPLOYEE OF THE CITY GOVERNMENT, PUBLIC SCHOOL TEACHERS, MEMBERS OF THE PHILIPPINE NATIONAL POLICE AND OTHER NATIONAL GOVERNMENT EMPLOYEES WHO ARE HOLDING THEIR OFFICES IN THE CITY HALL OF MUNTINLUPA AND ALLOCATING SEVEN MILLION PESOS (P7,000,000.00) TO PURCHASE THE REQUIRED SACKS OF RICE WHICH AMOUNT SHALL BE TAKEN FROM THE SAVINGS OF THE PERSONAL SERVICES 1999 EXECUTIVE BUDGET.

WHEREAS, there is a budget of Seven Million Pesos (P7,000,000.00) from the Personal Services savings, 1999 Executive Budget;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED that this ordinance granting incentive for the year 1999 of one (1) sack of rice to each employee of the City Government, public school teachers, members of the PNP and other national government employees who are holding their offices in the City Hall of Muntinlupa and allocating Seven Million Pesos (P 7,000,000.00) for the purchase of the required sacks of rice which amount shall be taken from the savings of the Personal Services, 1999 Executive Budget, *be approved.*
