BE IT ORDAINED by the *Sangguniang Panlungsod of Muntinlupa* in session assembled that certain provisions of Ordinance No. 99-038 are amended to be read as follows:

SECTION 1. *Section 2 – COMPOSITION. The Workers Affairs Office shall be composed of:*

- a. *Assistant Department Head I - SG - 23*
- b. *Administrative Officer III - SG - 18*
- c. *Two (2) Public Relations Officers I - SG - 11*
- d. *One (1) Clerk IV - SG - 8*

SECTION 2. *Section 4. The Assistant Department Head I shall be the head of the Department. He shall make plans and programs to implement the aims/purposes provided for in this ordinance.*

SECTION 3 *Section 5. The Administrative Officer III shall assist the Assistant Department Head I in the plans and programs to implement this ordinance.*

SECTION 4. *Section 6. The two (2) Public Relations Officers I and one (1) Clerk shall perform their duties assigned by the Assistant Department Head I or, in the absence of the Assistant Department Head I, by the Administrative Officer III.*

SECTION 5. *Section 7. SALARIES. The Assistant Department Head I, Administrative Officer III, two (2) Public Relations Officers I, and one (1) Clerk shall receive their salaries according to law.*


