WHEREAS, on 18 August 1997, the City Government of Muntinlupa passed a Resolution No. 97-068 urging the Department of Justice (DOJ) to conduct prior consultation with the City Government of Muntinlupa, the employees of Bureau of Corrections, the residents of the New Bilibid Prisons (NBP), different Non-Governmental Organizations (NGO'S) and People's Organizations (PO'S) before the development plan of the New Bilibid Prison (NBP) is finalized;

WHEREAS, the said resolution is based on the provisions of the New Local Government Code of 1991, specifically Sections 27 and 26 and Section 2(c) thereof, requiring prior consultation with the Local Government Unit (LGU) concerned regarding any plan or project to be implemented by the National Government in the said Local Government Unit (LGU);

WHEREAS, on 10 September 1997 said Resolution was forwarded to the then Secretary of Justice Hon. Teofisto Guingona;

WHEREAS, on 26 October 1998, his Excellency, President Joseph Ejercito Estrada, signed Executive Order No. 33 creating a Presidential Committee to study and take charge of the modernization and development of various penal institution in the country;

WHEREAS, in the said Executive Order, the National Penitentiary at Muntinlupa City was specifically mentioned regarding the probability of transferring said penal institution or disposing the same by the National Government;
