RESOLUTION APPROVING THE REQUEST OF THE SAMAHANG MAGKAKAPITBAHAY, INC. TO BORROW ONE MILLION ONE HUNDRED NINETY FIVE THOUSAND TWO HUNDRED PESOS (P1,195,200.00) TO PAY THE ACQUISITION OF A PARCEL OF LAND WITH AN AREA OF 900 \$QUARE METERS, MORE OR LESS, OWNED BY FORTUNATO DE MESA, ARMANDO DE MESA, EMILIANA DE MESA BUNYI, FORTUNATA DE MESA, ANGEL DE MESA, ALBERTO DE MESA AND BEATRIZ DE MESA, LOCATED AT ALABANG, MUNTINLUPA CITY, FOR ITS HOUSING PROJECT THROUGH THE NHMFC, WHICH AMOUNT SHALL BE TAKEN FROM THE LAND BANKING PROGRAM 1999 EXECUTIVE BUDGET.

WHEREAS, the association agreed to execute a Deed of Real Estate Mortgage or Deed of Assignment or a Memorandum of Agreement that once the NHMFC releases the check(s) in payment for the purchase price of the lot, said payment shall be given to the City Government as payment of the loan granted to the association and paid to the registered owners. Further, the association agreed to directly pay the monthly amortization to the City Government and make the lot as security for the loan in the event that the NHMFC is unable to release the payment of the lot and that this condition should be incorporated in the Deed of Assignment or Memorandum of Agreement or Deed of Mortgage

WHEREAS, there is a fund available under the Land Banking Program of the City Government.

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, to grant the request of the Malayang Samahang Magkakapitbahay, Inc. to borrow One Million One Hundred Ninety Five Thousand Two Hundred Pesos (P1,195,200.00) to pay the cost of the lot covered by TCT S-74765 with an area of 900 square meters, more or less, located at Alabang, for the housing project of its members.

RESOLVE, FURTHER, AS IT IS HEREBY RESOLVED, that the City Mayor be authorized to sign for and in behalf of the City Government the Deed of Assignment or Memorandum of Agreement or Deed of Mortgage that may be executed relative to this loan.
