**WHEREAS**, the Department of Budget and Management issued Local Budget Circular No. 68, dated June 4, 1998 *providing Guidelines for the Implementation of the Revised Rates of Representation and Transportation Allowances* in the Local Government Units;

**WHEREAS**, under the said Local Budget Circular, *the City Mayor may authorize* the increase of the monthly commutable Representation and Transportation Allowances (RATA) of elected and appointed officials of local government unit *with the approval of the Sangguniang Panlungsod*;

**WHEREAS**, the revised rates of monthly Representation and Transportation Allowances of the said officials effective 1 January 1998 are as follows:

City Vice Mayor	2,500.00	3,650.00
Members of the City Council	2,125.00	2,650.00
Department Heads	2,125.00	2,650.00
Asst. Department Heads	1,750.00	2,200.00



**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED**, to approve the increase in the monthly Representation or Transportation Allowances (RATA) of the above-named officials.

**RESOLVE, FURTHER, AS IT IS HEREBY RESOLVED** that this increase *shall be retroactive on January 1, 1999.*






