A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO ENTER INTO CONTRACT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH EXPEDITION CONSTRUCTION CORPORATION FOR GARBAGE HAULING/COLLECTION AND DISPOSAL SERVICES FOR THE MONTH OF JUNE 1, 2012 TO DECEMBER 31, 2012 AMOUNTING TO SIXTEEN MILLION ONE HUNDRED TWENTY THREE THOUSAND EIGHT HUNDRED EIGHTY FIVE PESOS (PHP16,123,885.00) PER MONTH WITH THE TOTAL AMOUNT OF ONE HUNDRED TWELVE MILLION EIGHT HUNDRED SIXTY SEVEN THOUSAND ONE HUNDRED NINETY FIVE PESOS (PHP112,867,195.00).

**WHEREAS**, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

**WHEREAS**, the contract for the collection, hauling and disposal of garbage in the City of Muntinlupa with Expedition Construction Corporation was authorized by **Sanggunian Resolution No. 12-220** stating therein that the contract of services shall be from **January 1 to 30 April, 2012**;

**WHEREAS**, the City of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the Contract for Garbage Collection and Disposal Services of the City of Muntinlupa for 2012, in two (2) newspapers of nationwide in general circulation and posted the same in the G-EPS and in a conspicuous place at the premises of the City Hall of Muntinlupa continuously for seven (7) days;

**WHEREAS**, the Bids and Award Committee declared EXPEDITION Construction Corporation as the bidder with the calculated and responsive bid last **April 11, 2012** for the Contract for Garbage Hauling, Collection and Disposal Services of the City of Muntinlupa for 2012;

**WHEREAS**, in response to said advertisement, there were two (2) bidders (**Expedition Construction Corporation and Severiano B. Hain Enterprises**) who submitted an application for eligibility and was declared eligible, whose technical and financial proposal, opened on the same day on **April 30, 2012** passed the preliminary examination of bids;

**WHEREAS**, on **May 4, 2012**, the Bids and Awards Committee (BAC) approved **Resolution No. 0010-12**, "declaring the Expedition Construction Corporation as the bidder with the Lowest Calculated Responsive Bid for the Garbage Hauling and Disposal Services of the City of Muntinlupa for 2012" and recommend the approval by the City Mayor;

**WHEREAS**, upon post qualification and careful examination, evaluation and verification of the eligibility, technical and financial requirements submitted by the two bidder with the calculated bid, the **EXPEDITION Construction Corporation** was found to be responsive;

**WHEREAS**, the Bids and Award Committee recommended to the City Mayor the approval of the foregoing findings;

**WHEREAS**, the contract shall be effective for a period of **seven (7)** months from **June 1 to December 31, 2012**;

**WHEREAS**, as certified by the Budget Office there is a budget appropriated for Garbage Collection and Disposal Services amounting to **One Hundred Ninety Five Million Pesos (Php195,000,000.00)** under the **2012 Executive Budget**;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Aldrin L. San Pedro** to enter into contract in behalf of the City Government of Muntinlupa with **Expedition Construction Corporation** for garbage hauling, collection and disposal services for the month of **June 1, 2012 to December 31, 2012** amounting to **Sixteen Million One Hundred Twenty Three Thousand Eight Hundred Eighty Five Pesos (Php16,123,885.00)** per month with the total amount of **One Hundred Twelve Million Eight Hundred Sixty Seven Thousand and One Hundred Ninety Five Pesos (Php112,867,195.00)**.


