A RESOLUTION RATIFYING THE EXTENSION OF CONTRACT OF EXPEDITION CORPORATION FOR THE GARBAGE HAULING AND DISPOSAL SERVICES WITH THE CITY GOVERNMENT OF MUNTINLUPA THROUGH THE HON. CITY MAYOR ALDRIN L. SAN PEDRO FOR THE PERIOD MAY 01 TO MAY 31, 2012, UNDER THE SAME TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT IN THE AMOUNT OF FOURTEEN MILLION (PHP14,000,000.00) PESOS PER MONTH.

WHEREAS, the City Mayor Hon. Aldrin L. San Pedro seeks to secure the grant of authority from the Sangguniang Panlungsod of Muntinlupa, as legislative body, to extend the City Government's Contract with Expedition Corporation for the garbage hauling and disposal services within the territorial jurisdiction of the City of Muntinlupa;

WHEREAS, the contract for the collection, hauling and disposal of garbage in the City of Muntinlupa with Expedition Construction Corporation was authorized by Sanggunian **Resolution No. 12-220** stating therein that the contract of services shall be from **January 1 to 30 April, 2012**;

WHEREAS, the Bid and Awards Committee (BAC) of the City approved **BAC Resolution Number 2012-001**, recommending the approval of the extension of contract of the City Government with Expedition Corporation for garbage hauling and disposal services from **May 1 to May 31, 2012** under the same terms and conditions of the original contract at a contract price of **Fourteen Million Pesos (Php14,000,000.00)** per month;

WHEREAS, Section 22 (c) of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that, **"every local government unit, as a corporate shall xxx unless otherwise provided in this Code, no contract maybe entered into by the local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned"**

WHEREAS, the contract extension is imperative to maintain the cleanliness of the entire city, to prevent the breakdown in sanitation, and to ensure the health and well being of the people of Muntinlupa;

WHEREAS, the contract extension is undertaken due to circumstances beyond the procuring entity's control and it cannot award a new contract within a month after the expiration of the term of the original contract;

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Act and its Implementing Rules and Regulations Part A (IRR-A) took effect on 26 January 2003 and 08 October 2003, respectively;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod of Muntinlupa, to confirm and ratify the extension of contract of **Expedition Corporation** for the Garbage Hauling and Disposal Services with the City Government of Muntinlupa through the **Hon. City Mayor Aldrin L. San Pedro** for the period **01 May to May 31, 2012**, under the same Terms and Conditions of the original Contract in the amount of **Fourteen Million (Php14,000,000.00) Pesos** per month.
