
WHEREAS, Republic Act No. 9640, an act amending Section 140 (a) of Republic Act No. 7160, otherwise known as "the Local Government Code of 1991, states that, the province may levy an amusement tax to be collected from proprietors, and other places of amusement at a rate of not more than ten percent (10%) of the gross receipts from admission fees, which took effect starting September 2, 2009";

WHEREAS, Cinemalaya sough the approval of the City Government of Muntinlupa, thru the Sangguniang Panlungsod for amusement tax exemption for the 9th Cinemalaya Phlippine Independent Film Festival" scheduled from **June 27** to August 4, 2013 at the Alabang Town Center, Barangay Ayala-Alabang, Muntinlupa City:


