

ORDINANCE NO. 13-016

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE AMOUNTING TO ONE MILLION PESOS (PHP1,000,000.00) TO THE PROVINCIAL GOVERNMENT OF BOHOL FOR THE RELIEF OPERATIONS OF AFFECTED FAMILIES IN THE VARIOUS MUNICIPALITIES OF BOHOL DEVASTATED BY A SEVEN POINT TWO (7.2) MAGNITUDE EARTHQUAKE LAST OCTOBER 15, 2013 WHICH AMOUNT SHALL BE TAKEN FROM THE MUNTINLUPA CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND (MCDRRM).

WHEREAS, Section 4(b.4) of the Rules and Regulations Implementing Republic Act No. 8185, otherwise known as "an act amending Section 321(d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991", states that, "the local Sanggunian Panlungsod may authorize the Local Chief Executive through a resolution to assist in emergency operation in another locality";

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185, also states that, "a portion of the Calamity Fund may also be authorized to be used by the Local Government Unit concerned to provide financial assistance to the other Local Government Units.";

WHEREAS, Section 1 of Rule 18 of the Implementing Rules and Regulations of Republic Act No. 10121, otherwise known as the "an act strengthening the Philippine Disaster Risk Reduction and Management System (PDRRMS), providing for the National Disaster Risk Reduction And Management Framework (MDRRMF) and institutionalizing the National Disaster Risk Reduction and Management Plan (NDRRMP), appropriating funds therefore and for other purposes", allows a portion of the Muntinlupa City Disaster Risk Reduction and Management Fund (formerly Calamity Fund) to be used by the Local Government concerned to render financial assistance to other local government units like the Province of Bohol;

WHEREAS, on October 15, 2013, a magnitude of 7.2 earthquake devastated various municipalities in the Province of Bohol rendering thousands of families homeless and in dire need of immediate relief assistance;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the 7th Sangguniang Panlungsod of Muntinlupa to grant financial assistance of One Million Pesos (Php1,000,000.00) to the Provincial Government of Bohol for the relief operations of affected families in the various Municipalities of Bohol devastated by a Seven Point Two (7.2) Magnitude Earthquake last October 15, 2013 which amount shall be taken from the Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRM)".

ENACTED, by the 7th Sangguniang Panlungsod of Muntinlupa this 21st day of October, 2013, on its 15th Regular Session.
