AN ORDINANCE ALLOCATING THE AMOUNT FIVE MILLION PESOS (PHP5,000,000.00) TO BE USED FOR FINANCIAL ASSISTANCE, MOBILIZATION AND OTHER INCIDENTAL EXPENSES IN THE MUNICIPALITIES OF JARO AND ALANG-ALANG, LEYTE, AND OTHER PLACES AFFECTED BY TYPHOON YOLANDA THAT THE CITY MAY DECIDE TO HELP WHICH AMOUNT SHALL BE TAKEN FROM THE MUNTINLUPA CITY RISK REDUCTION MANAGEMENT FUND (MCRRDMF).

WHEREAS, the Municipalities of Alangalang and Jaro in the Province of Leyte are the local government units to be adopted by the City Government of Muntinlupa;

WHEREAS, on November 24, 2013 the Mayor of Jaro, Leyte Atty. Rolando T. Celebre wrote to the City Mayor Atty. Jaime R. Fresnedi detailing among others the immediate need of the people of Jaro, Leyte including the partial report of their monitoring disaster operations;
