ORDINANCE NO. 13-031

AN ORDINANCE GRANTING TEN THOUSAND PESOS (PHP10,000.00) TO EVERY HOUSEOWNER (WHOSE HOUSE ARE TOTALLY DAMAGED), THREE THOUSAND (PHP3,000.00) FOR **EVERY** HOUSEOWNER (PARTIALLY DAMAGED), FIVE THOUSAND PESOS (PHP5,000.00) TO EVERY HOUSE RENTER, FIVE THOUSAND PESOS (PHP5,000.00) FOR EVERY SHARER, AFFECTED BY THE FIRE ON DECEMBER 5 2013 AT LAGUERTA (LOOBAN), BARANGAY TUNASAN, CITY OF MUNTINLUPA WHICH AMOUNT SHALL BE TAKEN FROM THE 2013 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF).

WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, the City Government of Muntinlupa provide with other relief goods, basic needs like, food supplemental feedings and immediate home life utensils, etcs.;

WHEREAS, on December 5 2013, there were thirteen (13) house owners (totally damaged); One (1) House Owner (Partially Damage); Three (3) house renters (Totally Damage), one (1) house sharer; that were affected by the fire in Laguerta (Looban), Barangay Tunasan, City Of Muntinlupa;

WHEREAS, the owner of the houses, renters, sharers, boarders, were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in <u>a state of calamity</u>;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims: in the amount of One Hundred Fifty Three Thousand Pesos (Php153,000.00) to be distributed as follows:

WHEREAS, the Social Welfare and Development Office (SWDO) of the City has submitted a certified copy of the list of the homeowners, renters, sharers/boarders (totally damaged and partially damaged) and injured in coordination with the Barangay Chairman of Tunasan Hon. Walter G. Arcilla is made an integral part of this ordinance;

WHEREAS, there is an available fund from the 2013 Executive Budget under 5% Muntinlupa Disaster Risk Reduction and Management Fund (LDRRMF):

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod duly assembled to grant Ten Thousand Pesos (Php10,000.00) to every house owner (whose house are totally damaged), Three Thousand (Php3,000.00) for every house owner (partially damaged), Five Thousand Pesos (Php5,000.00) to every house renter, Five Thousand Pesos (Php5,000.00) for every sharer, affected by the fire on December 5, 2013 at Laguerta (looban), Barangay Tunasan, City of Muntinlupa which amount shall be taken from the 2013 Executive Budget under 5% Muntinlupa Disaster Risk Reduction and Management Fund (LDRRMF).

ENACTED, by the 7th Sangguniang Panlungsod of Muntinlupa this 9th day of December 2013 on its 3rd Special Session.


