ORDINANCE NO. 14-046

AN ORDINANCE GRANTING TEN THOUSAND PESOS (PHP10,000.00) TO EVERY HOUSEOWNER (TOTALLY DAMAGED) THREE THOUSAND PESOS (PHP3,000.00) FOR HOUSE OWNER (PARTIALLY DAMAGED) FIVE THOUSAND PESOS (PHP5,000.00) TO EVERY HOUSE RENTER, FIVE THOUSAND PESOS (PHP5,000.00) FOR EVERY SHARER, THREE THOUSAND (PHP3,000.00) TO EVERY HOUSE BOARDER, FIVE THOUSAND PESOS (PHP5,000.00) FOR EVERY INJURED, OTHER ASSISTANCE LIKE SACKS OF RICE, GROCERIES, AND SCHOOL SUPPLIES FOR CHILDREN WHO ARE STUDYING, AFFECTED BY THE FIRE ON FEBRUARY 26, 2014, IN PUROK 4, EXTENSION, DULO ALABANG, BARANGAY ALABANG, CITY OF MUNTINLUPA WHICH AMOUNT SHALL BE TAKEN FROM THE 2014 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY RISK REDUCTION DISASTER AND MANAGEMENT FUND (MCRRDMF).

WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on **FEBRUARY 26, 2014 at Purok 4 Extension, Dulo Alabang, Barangay Alabang, City of Muntinlupa**, a fire totally destroyed houses and affected families;

WHEREAS, the owner of the houses, renters, sharers, boarders, were rendered homeless by reason of the said conflagration;

WHEREAS, the City Government shall also give other assistance like: sacks of rice, groceries, other immediate need of the affected families and school supplies for children who are presently studying;

WHEREAS, the Social Welfare and Development Office (SWDO) recommended to declare the affected area as in a state of calamity;

WHEREAS, the **Social Welfare and Development Office (SWDO)** of the City has submitted a certified copy of the list of the homeowners, renters, sharers/boarders (totally damaged and partially damaged) and injured in coordination with the **Barangay Chairman of Alabang Hon. Ariel J. Gonzaga** is made an integral part of this ordinance;

WHEREAS, there is an available fund from the 2014 Executive Budget under 5% Muntinlupa Disaster Risk Reduction and Management Fund (LDRRMF);

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod duly assembled to grant **Ten Thousand Pesos (Php10,000.00)** to every house owner (totally damaged) **Three Thousand Pesos (Php3,000.00)** for every house owner (partially damaged); **Five Thousand Pesos (Php5,000.00)** to every house renter (whose houses are totally damaged), **Five Thousand Pesos (Php5,000.00)** for every sharers, and **Three Thousand (Php3,000.000)** to every house boarder, **Five Thousand Pesos (Php5,000.00)** for every injured, and other assistance like sacks of rice, groceries, and school supplies for children who are studying, affected by the fire on **FEBRUARY 26, 2014**, in **Purok 4, Extension, Dulo Alabang, Barangay Alabang, City of Muntinlupa** which amount shall be taken from the **2014 Executive Budget under 5% Muntinlupa City Risk Reduction Disaster and Management Fund (MCRDDMF)**.

ENACTED, by the **7th Sangguniang Panlungsod of Muntinlupa** this **3rd** day of **March 2014**, on its **29th Regular Session**.
