WHEREAS, Section 458 (a) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the Sanggunian Panlungsod is empowered to determine the positions, salaries, wages and other emoluments and benefits of officials and employees, paid wholly or mainly from the city funds and provide for the expenditures necessary for the proper conduct of programs, projects, services and activities of the city government.":

WHEREAS, Article 99 of the Implementing Rules and Regulations of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "the Sanggunian Panlungsod, as the Legislative Body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city";

WHEREAS, Article 163 of the Implementing Rules and Regulations of the same Code, provides that, "the local government unit shall design and implement its organizational structure and staffing pattern taking into consideration its priority needs, service requirements and financial capabilities, consistent with the principles of simplicity, efficiency, economy, effectiveness, dynamism and public accountability subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC)".

WHEREAS, Mrs. Lualhati S. Morales, wrote a letter to the City Mayor regarding the 2015 Proposed Restructuring and creation of seven Plantilla Positions for the Budget and Management Office;

WHEREAS, the Hon. City Mayor Atty. Jaime R. Fresnedi, endorsed to the Sangguniang Panlungsod the proposed creation of seven (7) Plantilla Positions for Budget Office dated August 22, 2014;

WHEREAS, the budget officer justified the implementation of the "participative budgeting process" within the department/offices of the City Government. The department/office are required to propose, prepare and submit their own budgets using the different forms, taking into consideration the City's objectives and priorities that are aligned with the five (5) National key priority areas, keeping in mind also their own mandated roles/functions. More regular consultations, close coordination and guidance will facilitate the achievement of a common goal, in bridging the gap between the people and the City Government;

WHEREAS, the foregoing functions increased not only the workload but also broadened the role of their office, hence, restructuring of the organization and creation of positions is essential for clear cut and proper delineation of duties and responsibilities to meet the needs of the every offices/departments of the City Government of Muntinlupa;

WHEREAS, there is budget allocation for the propose seven (7) plantilla positions from the proposed 2015 Executive Budget amounting to Four Million One Hundred Twenty Five Thousand, Four Hundred Sixty Pesos and 84/100 (Php4,125,460.84);

NOW THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 7<sup>th</sup> Sangauniang Panlungsod of Muntinlupa, in session assembled that:

SECTION 1. This ordinance shall be known as "an ordinance creating Seven (7) Plantilla Positions In The Budget And Management Office And Appropriating Funds For The Compensation Of Personnel To Be Assigned Thereat And For Other Purposes."

SECTION 2. Creation of Plantilla Positions. The following Seven (7) Plantilla Positions from every Division with corresponding numbers, salary grade and Item is hereby created to wit:

Appropriations - The basic annual compensation of personnel who will fill-up the Plantilla Positions as herein-above created is hereby appropriated, which amount shall be taken from the General Fund of the City Government of Muntinlupa.

SECTION 4. Implementing Guidelines. The City Personnel Office is hereby mandated and shall see to it that the Plantilla Positions as herein created for the Budget and Management Office is accordance with the qualifications standard of the Civil Service Commission (CSC) and in conformity with the existing policy of the Department of Budget and Management (DBM).

SECTION 5. Separability Clause. If any portion of this Ordinance is declared invalid, the remaining of this Ordinance shall not be affected and shall remain valid and enforceable.

**SECTION 6.** Repealing Clause. All Ordinances, Implementing Rules and Regulations or part thereof where provisions are in conflict or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 7. Effectivity Clause. This Ordinance shall take effect upon its approval.

ENACTED, by the 7th Sangguniang Panlungsod of Muntinlupa, this 15th day of September 2014, on its 54th Regular Session.
