ORDINANCE NO. 14-086

AN ORDINANCE REQUIRING ALL CINEMA OWNERS/OPERATORS OPERATING WITHIN THE CITY OF MUNTINLUPA TO SET ASIDE ONE PESO (PHP1.00) COVERING THE PERIOD FROM DECEMBER 1, 2014 TO NOVEMBER 30, 2015 TO SUPPORT THE PROGRAMS AND PROJECTS OF THE SENIOR CITIZEN WITHIN THE CITY OF MUNTINLUPA.

WHEREAS, it is a declared policy of the State to give priority for the needs of the xxx, elderly, xxx, and in consonance with the said constitutional principle is to motivate and encourage the senior citizens to contribute to nation building;

WHEREAS, the Office of the Senior Citizens Affairs of the City of Muntinlupa was created thru Kautusang Bayan Bilang 93-25 by then Sangguniang Bayan last March 15, 1993 in compliance with the provisions of Republic Act No. 7432 which states that, "***an act to maximize the contribution of the senior citizens to nation building, grant benefits and special privileges and for other purposes***";

WHEREAS, Republic Act 7432, aims to establish a mechanism whereby the contribution of the senior citizens are maximized; to adopt measures whereby senior citizens are assisted and appreciated by the community as a whole; and to establish a program beneficial to the senior citizens, their families and the rest of the community that they serve;

WHEREAS, the 7th Sangguniang Panlungsod enacted Ordinance No. 13-021, entitled, "***an ordinance requiring all Cinema owners/operators operating within the City of Muntinlupa to set aside One Peso (Php1.00) covering the period from December 1, 2013 to November 30, 2014 to support the programs and projects of the Senior Citizen within the City of Muntinlupa***";

WHEREAS, a letter dated **October 24, 2014** was sent by **Mr. Ernesto M. Santos, OIC-OSCA** requesting to once again restore/continue the **One Peso (Php1.00)** share for every ticket purchased from all the operational cinemas around the city;

Ordinance No. 14-086

WHEREAS, in public hearing held by the Committee on Veterans, Retirees, elderly and Persons with Disability on **November 6, 2014**, the cinema representatives **posed no objection** to increase their cinema admission price by **One Peso (Php1.00)** to support the programs and projects of the senior citizens within the City of Muntinlupa;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 7th **Sangguniang Panlungsod** in session assembled that:

SECTION 1. Coverage - All cinema owners and operators operating within the City of Muntinlupa are hereby required to increase their cinema admission price by One Peso (Php1.00), covering the period from **December 1, 2014 to November 30, 2015**.

SECTION 2. Copy of this ordinance shall be posted to every cashier's booth of the cinemas operating within the City to inform the moviegoers about the contents of the same.

SECTION 3. The remittance to the City Treasurer's Office by cinema owners and operators of all monies collected from the increase shall be made on a monthly basis, simultaneous with the payment of amusement tax.

SECTION 4. The City Treasurer's Office shall within **ten (10)** days from receipt of all movie cinemas inform the City Council in writing as to the exact amount the said office received from the cinema operators.

SECTION 5. This ordinance shall take effect upon its approval and only within the covered period.

ENACTED, by the 7th **Sangguniang Panlungsod of Muntinlupa** this 24th day of **November 2014**, on its 62nd **Regular Session**.
