WHEREAS, on 17<sup>th</sup> day of November, the 7<sup>th</sup> Sangguniang Panlungsod enacted Ordinance No. 14-085, entitled, An Ordinance ratifying/affirming the Supplemental Budget amounting to One Hundred Eighty Four Million Eight Hundred Seventy Four Thousand Pesos (Php184,874,000.00), unappropriated surplus/savings from the net incomes of previous years as of December 31, 2013 which is unappropriated in the 2014 Executive Budget”;

WHEREAS, the City Mayor Hon. Atty. Jaime R. Fresnedi, endorsed the request of Ms. Analyn A. Mercado, OIC Muntinlupa City Disaster Risk Reduction and Management Office for the purchase of CCTV Cameras for City Hall premises amounting to **Thirteen Million Nine Hundred Thousand Pesos (Php13,900,000.00)**;

WHEREAS, the purchase/installation of CCTV camera shall comply with the bidding process as provided in Republic Act No. 9184, otherwise known as the Government Procurement Reform Act;

NOW THEREFORE BE IT ORDAINED, AS IT HEREBY, ORDAINED, by the 7<sup>th</sup> Sangguniang Panlungsod, to allocate Thirteen Million Nine Hundred Thousand Pesos (Php13,900,000.00) for the installation/purchase of CCTV Cameras for the City Hall premises which amount shall be taken from the 2014 Supplemental Budget Of The City Government Of Muntinlupa.


