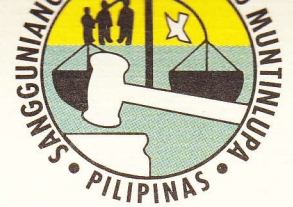

WHEREAS, Article 99 (iv), of the Local Government Code of 1991, Implementing Rules and Regulations, provides that, "the Sangguniang Panlungsod as legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, since July 15, 2014, a wide area of Luzon was besieged by typhoon Glenda;

WHEREAS, the National Capital Region (NCR), including the City of Muntinlupa is greatly affected by typhoon Glenda;

WHEREAS, typhoon Glenda which speed reaches a maximum of more or less one hundred and fifty (150) kilometers with a radius of two hundred fifty (250) miles brought destruction to houses, government and private building as well as destruction of trees and natural landscape;

WHEREAS, there is a need to extend basic services as well as financial support to the affected Muntinlupa constituents in order that normalcy is achieved in the short span of time enabling residents to continue in their usual day to day living;

WHEREAS, as a whole, the lives and properties of the people in the affected areas, if not given immediate care and assistance by the City Government of Muntinlupa, including their health, sanitation, means of livelihood and education, are in grave jeopardy;

WHEREAS, the *Social Services Department (SSD)* and the *Muntinlupa City Disaster Risk Reduction Coordinating Council (MCDRRCC)* recommended to declare the entire City of Muntinlupa as in a state of calamity;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 7th *Sangguniang Panlungsod*, to declare as in as in state of calamity the entire City of Muntinlupa which is affected by typhoon "Glenda", which besieged a wide area of Luzon since July 15, 2014.

ADOPTED, by the 7th *Sangguniang Panlungsod* of Muntinlupa this 16th day of July 2014, on its 10th Special Session.


