A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH DL CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF RIPRAP AND PERIMETER FENCE LOCATED AT BOUNDARY OF PACWOOD AND SIKATVILLE, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF (PHP3,571,580.54) WHICH AMOUNT SHALL BE TAKEN FROM THE 2013 CONTINUING APPROPRIATION - 2014 EXECUTIVE BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND (CDF).

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "*xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others*";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "*any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "*saw no need to seek authority from the City Council prior to entering into a contract*";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the Construction of Riprap and Perimeter Fence located at Boundary of Pacwood and Sikatville, Barangay Tunasan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) contractor submitted letter of intent and application for eligibility, and one (1) was found eligible on July 1, 2014;

WHEREAS, one (1) bidder was submitted on July 1, 2014 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, *D.L Cervantes Construction Corporation* its bid has been found responsive to **Approved Budget for the Contract (ABC)**;

WHEREAS, the amount appropriated for the said project shall be taken from the 2014 Executive Budget under Continuing Appropriations (CA) - 20% Community Development Fund (CDF);

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of Riprap and Perimeter Fence is *Three Million Five Hundred Seventy Eight Thousand Seven Hundred Fifteen Pesos and 83/100 (Php3,578,715.83)*;

WHEREAS, the project was awarded to *D.L Cervantes Construction Corporation*, who being the lone and lowest bidder for the project, construction of Riprap and Perimeter Fence located at Boundary of Pacwood and Sikatville, Barangay Tunasan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with DL Cervantes Construction Corporation for the project Construction of Riprap and Perimeter Fence located at Boundary of Pacwood and Sikatville, Barangay Tunasan, Muntinlupa City in the amount of Three Million Five Hundred Seventy One Thousand Five Hundred Eighty Pesos and 54/100 (Php3,571,580.54) which amount shall be taken from the 2013 Continuing Appropriation - 2014 Executive Budget under the 20% Community Development Fund (CDF).

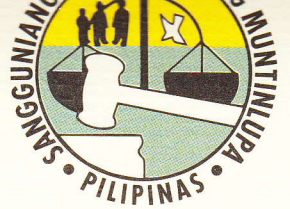




