SECTION 1. Title - This ordinance shall be known as, **"An Ordinance Granting Monthly Allowance/Honorarium to National Government Personnel stationed or assigned in the City of Muntinlupa"**.

SECTION 3. Appropriation - The said allowance/honorarium shall be taken from the **2015 Executive Budget**. The said allowance/honorarium shall be included in Executive Budget **every year thereafter** unless **revoked or amended by legislative action**.

SECTION 4. Copies of this Ordinance shall be furnished to the Office of the *City Budget, City Treasurer, Accounting Office, City Auditor, City Prosecutor and Executive Judges of the RTC and MTC and Head of Public Attorney Office (PAO)* and other national government offices concerned for their information;

SECTION 5. Separability Clause – If for any reason or reasons any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 7. Effectivity Clause – This ordinance shall take effect from **January 1, 2015**.






