WHEREAS, on **February 5, 2015**, Mr. Ernesto M. Santos wrote a letter seeking the approval for the bestowing of cash grants to the Senior Citizens of Muntinlupa aged 100 years old and above;

WHEREAS, this grant is dubbed as Muntinlupa Centenarians with Annual Investment Plan Reference Code 3000-500-3-1-6 where each will be given **Twenty Five Thousand Pesos (Php25,000.00)**;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 7th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. This ordinance shall be known as "**an ordinance granting Senior Citizens of Muntinlupa City who are 100 years and above the amount of Twenty Five Thousand Pesos (Php25,000.00) each Every Year Which Amount Shall Be Taken From The 2015 Executive Budget**"

SECTION 2. Funding – the funds to be allocated shall be taken from the Senior Citizens and disabled program – MOOE- Non Office 2015 Executive Budget and shali be provided in the **Executive Budget every year starting 2016.**

SECTION 3. This ordinance shall be given to Senior Citizens of Muntinlupa City whose age is 100 years and above.

SECTION 4. Requirements - To avail/acquire this ordinance the beneficiaries shall be required to submit the following requirements:

1. *Senior Citizen Identification Card issued by OSCA;*
2. *Barangay Certification that the said Senior Citizen is a legitimate residents of Muntinlupa City;*
3. *Certification from the President of their respective Senior Citizens Organizations;*

SECTION 5. Separability Clause – If for any reason or reasons any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 7. Effectivity – This Ordinance shall take effect upon its approval.

ADOPTED, by the 7th *Sangguniang Panlungsod of Muntinlupa* this 23rd day of *March 2015*, on its 75th *Regular Session*.





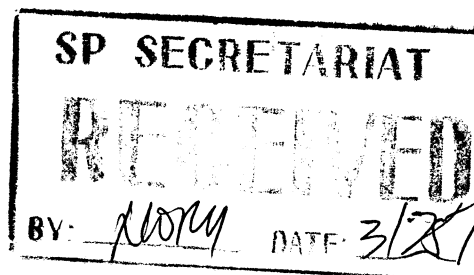
