NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7th Sangguniang Panlungsod, committing to allocate the initial amount of **Twenty Million Pesos (Php20,000,000.00)** for the reclamation of 6 hectares land located along Sport Complex, Barangay Tunasan, Muntinlupa City to be taken from the 2015 Executive Budget Infrastructure – Capital Outlay and additional fund for next year needed for the said project in the 2016 Executive Budget and the year thereafter if it is necessary.






