WHEREAS, for passing the **Seal of Good Local Governance (SGLG)**, the City of Muntinlupa is awarded with the Performance Challenge Fund amounting to **Five Million Pesos (Php5,000,000.00)**;

WHEREAS, per DILG Memorandum Circular No. 2015-78, eligibility to be a recipient of the PCF is dependent on the compliance of administrative requirements specified therein and one of which is a resolution from the Sanggunian that authorizes the Local Chief Executive to enter into a Memorandum of Agreement with the DILG;
