**WHEREAS**, from 2010, the *Seal of Good Housekeeping* has promoted transparency and accountability in local government operations;

**WHEREAS**, the Memorandum Circular No. 2014-39 of the Department of Interior and Local Government scales up the *Seal of Good Housekeeping* into the *Seal of Good Local Governance* to promote not only transparency and accountability in the use of public funds but includes preparedness for challenges posed by disasters, sensitivity to the needs of the vulnerable and marginalized sectors of the society, investment and employment and environmental protection;

**WHEREAS**, Memorandum Circular No. 2014-39 likewise sets parameters within which the assessment should be based such as Good Financial Housekeeping, Disaster Preparedness, Social Protection, Business Friendliness and Competitiveness, Peace and Order, Environment Management;

**WHEREAS**, assessment was conducted covering eighty (80) provinces, One Hundred Forty Three (143) cities and One Thousand Four Hundred Ninety One (1,491) municipalities;

**WHEREAS**, the City of Muntinlupa went through a rigorous assessment made by the Regional Assessment Team from Caloocan City;

**WHEREAS**, on July 28, 2015 the DILG issued an Official List of *Seal of Good Local Governance* passers. Out of One Hundred Forty Three (143) Cities, the City of Muntinlupa is one of the only three (3) local government units to pass the *Seal of Good Local Governance*;
