(I)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on October 17, 2015 at Purok 6, Vivo Compound, Barangay Bayanan, City Of Muntinlupa, a fire totally destroyed houses and affected families;

WHEREAS, the owner of the houses, renters, and sharers/boarders were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in a state of calamity;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 7<sup>th</sup> Sangguniang Panlungsod, to declare the area affected by the fire/conflagration on October 17, 2015 at Purok 6, Vivo Compound, Barangay Bayanan, City Of Muntinlupa, as in a State of Calamity.
