WHEREAS, Memorandum Circular No. 2013-64 of the Department of Interior and Local Government (DILG) created a program known as **Newly Elected Official Program or NEO Program** comprised of **four (4) programs** which will bring about a cadre of development roadmap that promotes economic development in Local Government Unit (LGU);

WHEREAS, one of the component of **NEO Program** is the **crafting of the Executive-Legislative Agenda (ELA)** which shall include a competency-based capacity development agenda formulated to contain the governance program of the local government unit for **three (3) years** corresponding to the term of the office of the elected official that promote partnership between the Local Chief Executive and the Legislative Department and the involvement of multi stakeholders in the identification and programming of the three-year development priorities;

WHEREAS, in compliance with Memorandum Circular No. 2013-64, the City of Muntinlupa conducted a dialogue between the Executive and Legislative Department for the crafting of the Executive-Legislative Agenda for the period 2013-2016;

WHEREAS, on December 13, 2013 the Executive-Legislative Agenda (ELA) for the period 2013-2016 was finally adopted by both the Local Chief Executive and the members of the City Council;

NOW THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, by the 7th Sangguniang Panlungsod of Muntinlupa, to adopt the Executive and Legislative Agenda (ELA) for the Year 2013 to 2016 of the Local Government of Muntinlupa City.


