ROSA, LAGUNA UNDER THE PROGRAM/PROJECT OF THE NATIONAL GOVERNMENT OPLAN LIKAS WHICH AMOUNT SHALL BE TAKEN FROM 2016 EXECUTIVE BUDGET SOCIALIZED HOUSING, LANDBANKING, COMMUNITY MORTGAGED PROGRAM AND OTHER RELATED ACTIVITIES UNDER THE NON-OFFICE MOOE.

**WHEREAS**, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx and shall";

**WHEREAS**, the Urban Poor Affairs Office (UPAO) requested the grant of **Ten Thousand Pesos (Php10,000.00)** financial assistance to the **Four Hundred Twenty Four (424)** relocated volunteer families which were transferred to Villa Sta. Rosa, Laguna under the **Oplan LIKAS (Lumikas para Iwas Kalamidad at Sakit)** program of the national government;

**WHEREAS**, there is a need for the City Government to give financial assistance to the aforesaid individuals;

**WHEREAS**, as certified by the Budget Office that there is an available fund from the 2016 Executive Budget under the **Socialized Housing, Landbanking, Community Mortgaged Program and Other Related Activities under the Non-Office MOOE**;

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED**, by the <sup>8<sup>th</sup></sup> Sangguniang Panlungsod duly assembled to grant financial assistance to **Four Hundred Twenty Four (424) families** who volunteered to be relocated and transferred to Villa Sta. Rosa, Laguna under the program/project of the National Government Oplan Likas which amount shall be taken from 2016 Executive Budget under the **Socialized Housing, Landbanking, Community Mortgaged Program and Other Related Activities under the Non-Office MOOE**.


