**WHEREAS**, on December 19, 2017, Muntinlupa shall enter its Centennial Year, a milestone that should be given importance and commemoration befitting a local government unit with accomplishments we can be proud of to serve as testaments of our present and future generations;

**WHEREAS**, in cognizance of the need to have sufficient time in the preparations and promotions for the celebration of the 100<sup>th</sup> Founding Anniversary of Muntinlupa, a Muntinlupa Centennial Commission is necessary to be created to handle series of events, programs and activities;

**WHEREAS**, the Muntinlupa Centennial Commission shall ensure a more coordinated and synchronized celebration of the 100<sup>th</sup> Founding Anniversary of Muntinlupa and wider participation of the government, Non-Government Organizations (NGOs) and Private Organizations (POs);

**WHEREAS**, the celebration will have series of events, programs and activities that require sufficient time and preparations. There is also a need to rationalize the relevance of this historic event to other countries especially our sister cities;

**NOW, ORDAIN, AS IT IS HEREBY ORDAINED**, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa in session assembled that:

**SECTION 1. Title** – This resolution shall be known as “An Ordinance Creating The Muntinlupa Centennial Commission For The Celebration Of The 100<sup>th</sup> Year Founding Anniversary of Muntinlupa And Appropriating Funds For The Purpose.”

**SECTION 2. Composition** - The Muntinlupa Centennial Commission shall be composed of the following:

1. City Administrator
2. Representative – Lone Congressional District of Muntinlupa City
3. City Cultural and Tourism Officer
4. Secretary to the Mayor
5. Head, Budget Management Office
6. Head, City Engineering’s Office
7. Head, City Architect’s Office
8. Head, Office of the City Attorney
9. Head, City Planning Office
10. City Vice Mayor
11. All Members of the Sangguniang Panlungsod
12. Superintendent of the Schools Division Office of the Department of Education, Culture and Sports)
13. Head, Local Economic and Investment Promotion Office
14. Head, Public Information Office
15. Head, Management Information System
16. Head, Office of the Senior Citizens
17. DILG City Director
18. President, Liga ng mga Barangay
19. Representative from National Historical Institute
20. Representative from the Philippine Chamber of Commerce and Industry, Muntinlupa City Chapter
21. Representative from Non-Governmental Organizations (NGO’s)
22. Representative from Muntinlupa Arts Society (MAS)
23. At least not more than five (5) members from Government or Private Sector when necessary.

The Chairman of the Muntinlupa Centennial Commission shall be the City Administrator. The Chairman shall designate the Vice-Chairman and representatives of the following:

1. Representative from National Historical Institute
2. Representative from the Philippine Chamber of Commerce and Industry, Muntinlupa City Chapter
3. Representative from Non-Governmental Organizations (NGO’s)
4. Representative from Muntinlupa Arts Society (MAS)

5. *At least not more than five (5) individuals with expertise, experience and special knowledge as members from Government or Private Sector, when necessary, who shall be designated by the City Administrator as Chairman of the Commission.*

**SECTION 3.** The Commission shall plan, coordinate and implement the programs and projects of the centennial celebration.

**SECTION 4.** The Chairman of the Commission shall create sub-committees as many as necessary to assist in the planning, coordinating and implementing the programs, projects and activities. The sub-committees shall be headed by Chairman, Vice-Chairman and at least not less than two members who shall be appointed by the Chairman of the Sub-Committee, subject to approval of the Chairman of the Muntinlupa Centennial Commission.

**SECTION 5.** The **Muntinlupa Centennial Commission** shall be provided with technical and administrative staff support, a Secretariat and a Consultant to be formed/appointed by the Chairman of the Commission.

**SECTION 6. Appropriation** - The **Muntinlupa Centennial Commission** and its programs, projects and activities for the year 2016 shall be funded from the Special Activities Fund (SAF) of the City Mayor, in an amount to be recommended by the Commission and approved by the Local Chief Executive.

The budget of the **Muntinlupa Centennial Commission** and its programs, projects and activities shall be included in the 2017 Executive Budget. The release of the budget appropriation for 2016 and 2017 shall be in accordance with law, and accounting, rules and regulations.

**SECTION 7.** The Commission shall prepare for the approval of the City Mayor, a comprehensive plan of the programs, projects and activities for the Centennial Celebration upon approval of this Ordinance.

**SECTION 8.** The **Muntinlupa Centennial Commission** shall commence its work immediately upon approval of this ordinance and shall cease to exist on 31 March 2018 in order to prepare all the reports and documentation of the celebration.

**SECTION 9.** This ordinance shall take effect immediately upon its approval.

**ENACTED**, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa this 26<sup>th</sup> day of August 2016, on its 1<sup>st</sup> Special Session.


