## **ORDINANCE NO. 16-009**

AN ORDINANCE APPROVING THE REQUEST OF MILLENIUM HOMEOWNERS ASSOCIATION, INC., TO BORROW ONE HUNDRED NINETY FOUR THOUSAND PESOS (Php194,000.00) FOR THE PAYMENT OF EXPENSES FOR THE TRANSFER OF TITLE FROM THE LANDOWNER TO THE NAME OF THE ASSOCIATION LOCATED AT ZONE 2, SITIO PAGKAKAISA, BARANGAY SUCAT, MUNTINLUPA CITY FOR ITS HOUSING PROJECT WHICH AMOUNT SHALL BE TAKEN FROM THE LAND BANKING/SOCIALIZED HOUSING/COMMUNITY MORTGAGE AND OTHER RELATED ACTIVITIES FROM THE 2016 EXECUTIVE BUDGET.

d. Other expenses related to the acquisition of the land

WHEREAS, the association will pay the amount of Sixteen Thousand One Hundred Sixty Seven Pesos (Php16,167.00) for one (1) year and the eighty five (85) beneficiary will pay One Hundred Ninety Pesos and 20/100 (Php190.20) per month;

WHEREAS, the association will pay the said loan within **12 months** and will commence on January 1, 2017 as stated in the **Memorandum of Agreement (MOA)**;

WHEREAS, the City Government and the Association shall include in the *Memorandum of Agreement (MOA)* the terms and conditions of the payment scheme of the loan.

WHEREAS, there is an available fund from any available fund from the *Land Banking/Socialized Housing/Community Mortgage* and other related activities from the **2016 Executive Budget**.

ORDAIN, THEREFOR, AS IT IS HEREBY ORDAINED by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to grant the request of the MILLENIUM HOMEOWNERS ASSOCIATION, INC. to borrow One Hundred Ninety Four Thousand Pesos (Php194,000.00) for the payment of expenses for the transfer of title from landowner under the name of the Association located at Zone 2, Sitio Pagkakaisa, Barangay Sucat, Muntinlupa City for its housing project which amount shall be taken from the Land Banking/Socialized Housing/Community Mortgage and other Related Activities from the 2016 Executive Budget.

ORDAINED, FURTHER, that the City Mayor Atty. Jaime R. Fresnedi, be authorized to sign for and in behalf of the City Government a **Memorandum of Agreement (MOA)** that may executed relative to this loan.
