WHEREAS, on 26th day of August 2016, the 8th Sangguniang Panlungsod of Muntinlupa on its 1st Special Session passed Ordinance No. 16-005, entitled, "An Ordinance Creating The Muntinlupa Centennial Commission For The Celebration Of The 100th Year Founding Anniversary of Muntinlupa And Appropriating Funds For The Purpose.";

WHEREAS, the Local Finance Committee passed Resolution No. 6, Series of 2016, recommending the grant of Centennial Bonus to all city government employees;

WHEREAS, under the DBM Local Budget Circular No. 65, dated March 3, 1997, **Anniversary Bonus** may be granted to the City Employees in connection with the said 100th year anniversary subject to the guidelines;

WHEREAS, on **December 19, 2017** the City of Muntinlupa will be celebrating its 100th year of foundation;

WHEREAS, *Anniversary Bonus* in the amount not exceeding **Three Thousand Pesos (Php3,000.00)** shall be given to the employees who have rendered at least **one (1) year service** in the City Government as of the date of milestone year (**December 19, 2017**) except those employees who are suspended regardless of the duration of such suspension during the said period;

SECTION 1. Title – This ordinance shall be known as, “An Ordinance Granting The Centennial/Anniversary Bonus To All City Government Employees Amounting To Three Thousand Pesos (Php3,000.00) Each To Be Taken From 2017 Executive Budget..”

SECTION 2. Appropriation – The budget for the Centennial/Anniversary Bonus shall be allocated to the **2017 Executive Budget**.

SECTION 3. Coverage – All qualified employees of the City Government pursuant to fifth (5th) whereas clause shall be granted with the Centennial Anniversary Bonus.
