ORDINANCE NO. 16-028

AN ORDINANCE GRANTING FINANCIAL AND RELIEF ASSISTANCE TO THE MUNICIPALITY OF RIZAL, PROVINCE OF KALINGA WHICH WAS DEVASTATED BY TYPHOON LAWIN AMOUNTING TO ONE MILLION PESOS (Php1,000,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND (MCDRRMF) TO AID THEIR RECOVERY AND REHABILITATION PROGRAMS.

WHEAREAS, Rule 18, Section 2, of the Implementing Rules and Regulations of RA 10121, provides for a Quick Response Fund (QRF) intends for **“relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemics, or complex emergencies, may be normalized as quickly as possible”**;

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or An Act amending Section 324(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that, **“a portion of Calamity Fund may be authorized to be used by the LGU concerned to provide financial assistance to other LGUs”**;

WHEREAS, on **October 19, 2016** the **Province of Kalinga** have been hit by recent typhoon Lawin and the City Government of Muntinlupa aims to extend financial and relief assistance to two (2) affected Municipalities to the aforesaid province;

WHEREAS, the **Municipality of Rizal, Province of Kalinga** by virtue of Resolution No. 2016-49, is respectfully requesting **Hon. Mayor Atty. Jaime R. Fresnedi** and the **Honorable Members of Sangguniang Panglungsod of Muntinlupa City** through **Hon. Vice Mayor Celso C. Dioko**, to provide and extend financial and relief assistance to aid in their recovery and rehabilitation in the aftermath of the aforesaid typhoons;

WHEREAS, there is an available fund from the LDRRMF of the City Government of Muntinlupa to extend and provide assistance to **Municipality of Rizal, Province of Kalinga**;

WHEREAS, consequent to the grant of assistance to the **Municipality of Rizal, Province of Kalinga**, the City Government of Muntinlupa will be required to participate in the **Post Damage Assessment Needs Analysis (PDANA)** for the alignment of financial or relief assistance;

NOW THEREFOR, BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panglungsod of Muntinlupa, to grant financial and relief assistance to the **Municipality of Rizal, Province of Kalinga** which was devastated by typhoon Lawin in the amount of **One Million Pesos (Php1,000,000.00)** which shall be taken from the **5% Muntinlupa City Disaster Risk Reduction And Management Fund (MCDRRMF)** to aid their recovery and rehabilitation programs be approved.

ENACTED, by 8th Sangguniang Panlungsod of Muntinlupa, this 28th day of November 2016, on its 19th Regular Session.
