AN ORDINANCE AUTHORIZING, APPROVING, ESTABLISHING AND SUSTAINING THE RESIDENCY TRAINING PROGRAMS OF THE OSPITAL NG MUNTINLUPA.

WHEREAS, Section 15, Article II and Section 11, Article XIII of the Philippine Constitution mandates the protection and promotion of the right to health of the people and requires the adoption of an integrated and comprehensive approach to health development;

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the New Local Government Code of 1991 provides that every local government unit shall exercise powers essential to the promotion of the general welfare, and within their respective territorial jurisdictions shall ensure and support promotion of health and safety and development of appropriate and self-reliant scientific capabilities;

WHEREAS, Section 17 of the Republic Act No. 7160 further provides that the Local Government Units shall endeavor to be self-reliant and shall exercise powers for effective provision of basic services such as health services including hospitals and other tertiary health services;

WHEREAS, Administrative Order No. 2012 of the Department of Health (July 18, 2012) on the Rules and Regulations Governing the new Classification of Hospitals and Other Health Facilities in the Philippines requires that a level 3 hospital shall have a minimum requirement a teaching and/or training hospital with an accredited residency training program for physicians in the four (4) major specialties, namely, but not limited to: Internal Medicine, Pediatrics, Obstetrics and Gynecology, and General Surgery;

WHEREAS, Authorizing, Approving, Establishing and Sustaining the Residency Training programs in Ospital ng Muntinlupa for the major specialties will meet one of the requirements of the Department of Health to be classified as a level 3 hospital, thereafter allowing comprehensive and effective provision of health services in the hospital;

NOW THEREFOR, ORDAIN, AS IT IS HEREBY ORDAINED, the following:

SECTION 1. Declaration of Policy – it is a declared policy of the city to uphold the right of the people to health and adopt an integrated and comprehensive approach to health while promoting self-reliance and continued development.

It is further declared that establishing and sustaining a Residency Training Program in Ospital ng Muntinlupa shall allow it to become a Level 3 Hospital, in accordance with its vision of being one of the best sustainable centers of wellness in the Philippines, in service of the community.

SECTION 2 . Objectives – the objectives of this resolution are as follows:

- a. *Authorize, Approve, and Establish a Residency Training program for physicians initially in the four (4) major specialties namely: Medicine, Pediatrics, Obstetrics & Gynecology and Surgery*
- b. *Sustain the Residency Training program through support of policies and programs to have the residency program accredited by appropriate specialty societies, and ensure the standard by which quality of care is delivered*
- c. *Support the development of review and monitoring policy for the Residency Training Program to ensure its growth and sustainability.*

SECTION 3. Residency Training Committee – Ospital ng Muntinlupa shall establish training committee for each specialty.

The Residency Training Committee of each specialty shall be composed of one (1) Chair, one (1) Vice-Chair, and one (1) Training Officer, who shall be appointed by the Hospital Director from the pool of Ospital ng Muntinlupa's active consultants, from each specialty, respectively.

SECTION 4. Functions. The Residency Training Committee of each specialty shall have the following functions:

- a. *Review, formulate and implement policies and guidelines on Residency Training Program and related concerns, to ensure the program's accreditation, development, improvement and sustainability.*
- b. *Develop a comprehensive and integrated program, including regular monitoring and evaluation, with the aim of training physicians in each specialty, based on the standards of the respective specialty boards, and in accordance with values of excellence and service.*

c. Provide technical supervision in the implementation of the Residency Training program, to comply with accreditation policies and requirements, and relevant laws and regulations.

d. Perform such other duties and functions necessary in carrying the purposes of this ordinance.

SECTION 5. Residents in Training. Each specialty's residency training program shall recruit their respective "residents-in-training" based on the criteria set by each Specialty.

The appointment of all the residents-in-training shall be only Full Time Temporary, approved by the City of Muntinlupa, as recommended by the Hospital Director of Ospital ng Muntinlupa, with their promotions, the succeeding year level based on annual evaluation of their skills, knowledge and attitude by their respective specialties. Their appointments shall be co-terminus with their completion of their respective training programs.

SECTION 6. Training Program. Each residency training program shall comply with their respective Specialty Boards in having a specified number of years of training to be completed by each of their residents-in-training:

| (1) General Surgery | – five (5) years |
| (2) Obstetrics & Gynecology | – four (4) years |
| (3) Internal Medicine | – three (3) years |
| (4) Pediatrics | – three (3) years |

SECTION 7. Number of Residents. All the specialties shall have a required minimum number of residents per training year level, namely:

| (1) General Surgery | – two(2) residents per year level |
| (2) Obstetrics & Gynecology | – two(2) residents per year level |
| (3) Internal Medicine | – five (5) residents per year level |
| (4) Pediatrics | – five (5) residents per year level |

There shall be a total of **forty eight (48)** residents-in-training across all the four specialties

SECTION 8. Appropriation. The City Government shall appropriate funds as may from year to year be necessary for the operation, maintenance and sustenance of the residency training programs, to be included in the annual general appropriations of the city government, based on the annual budget as proposed by Ospital ng Muntinlupa, with regard to the needed capital outlay and personnel, operating and maintaining expenses of the residency Training Programs.

SECTION 9. Repealing Clause. All ordinances, rules and regulations or parts thereof, in conflict with, or inconsistent to the provisions of this ordinance are hereby repealed or modified accordingly.






