**WHEREAS**, Section 458(I)(VI) of Republic Act 7160, otherwise known as the New Local Government Code of 1991, the Sangguniang Panlungsod is empowered to protect the environment and impose appropriate penalties for acts which endanger the environment xxx and such other activities which results in pollution or of ecological imbalance;

**WHEREAS**, Section 10 Chapter II of Republic Act 9003, known as Ecological Solid Waste Management Act of 2000 states that among others, "pursuant to the relevant provisions of RA 7160 the local government units shall be the primary responsible for the implementation and enforcement of the provisions of this Act within their respective jurisdiction;

**WHEREAS**, Muntinlupa City rapid urbanization has its fall-outs of collateral environmental problems one of which is solid waste – a common and continuing concern of all growing local government units;

**WHEREAS**, by virtue of Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, mandated all local government units to enforce laws and prepare a solid waste management program;

**WHEREAS**, in compliance with Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, the City Government of Muntinlupa, through the Solid Waste Management Board, formulated and adopted the Ten Years Solid Waste Management Plan for ratification of the City Council;

This 2<sup>nd</sup> Ten Year Solid Waste Management Plan and Environmental Protection (2015-2024) is a continuous improvement drive of systems, programs and processes towards implementation excellence.
