A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO AND SIGN THE CONTRACT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH METROWASTE SOLID MANAGEMENT CORPORATION FOR THE GARBAGE COLLECTION AND DISPOSAL SERVICES FROM MARCH 1, 2016 TO DECEMBER 31, 2016 AMOUNTING TO ONE HUNDRED NINETY FOUR MILLION, NINE HUNDRED TEN THOUSAND PESOS (Php194,910,000.00) FOR A PERIOD OF EIGHT (8) MONTHS WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET.

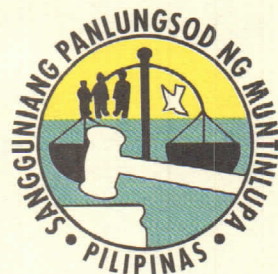

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to apply for Eligibility and to Bid of the Contract for Garbage Collection and Disposal Services of the City of Muntinlupa for the year 2016 once in a newspaper of nationwide general circulation, posted the same in the conspicuous place at the premises of the City Hall of Muntinlupa and posting of Invitation at PhilGEPS, Website and bulletin on **09/12/2015**;

**WHEREAS**, the issuance of Bidding documents dated **December 29, 2015**;

**WHEREAS**, the Pre-Bid Conference was conducted on December 29, 2015 and the submission and receipt with Opening of Bids and Eligibility Check was conducted on **December 29, 2015**;

**WHEREAS**, in response to said advertisement and/or posting, two bidders (2) submitted sealed bid/s on or before the deadline last December 29, 2015 which sealed bid was then opened on the same day December 29, 2015.

**WHEREAS**, the bid proposal, as read, of the participating bidders who passed preliminary examination were as follows:

**WHEREAS**, as noted by the Bids and Awards Committee (BAC), Bidder **Kampil Internet, Trading Inc.**, first bid envelope was rated as **FAILED** due to the incomplete technical specification documents, list of vehicles owned/leased, manpower schedule, certificate of training for drivers/paleros, SSS & PHILHEALTH Certificates, proposed location of office/terminal/list of employees/equipment.

**WHEREAS**, After careful examination, validation, and verification of all the eligibility, technical and financial requirement submitted by the above bidder with the lowest calculated bid **Metrowaste Solid Waste Management Corporation** its bid proposal has been found to be responsive.

**WHEREAS**, upon post-qualification and careful examination, evaluation and verification of the eligibility, technical and financial requirements submitted by the bidders with the calculated bid, the **Metrowaste Solid Waste Management Corporation** was found to be responsive;

**WHEREAS**, the **Bids and Awards Committee (BAC)** declared **Metrowaste Solid Waste Management Corporation** as the winning bidder for the contract for garbage collection and disposal services of the City of Muntinlupa for the period **March 1, 2016 to December 31, 2016**;

**WHEREAS**, in the public bidding that was conducted by the Bids and Awards Committee (BAC) the bid proposal by the **Metrowaste Solid Waste Management Corporation** was found to be the Lowest Calculated and Responsive Bid (LCRB) for which a Notice of Award has been issued by the City Mayor;

**WHEREAS**, there is a budget appropriated for the garbage collection and disposal services amounting to **One Hundred Ninety Five Million Pesos (Php195,000,000.00)** under the 2016 Executive Budget as certified by the Budget Officer;

**WHEREAS**, the bidding as per documents submitted to the City Council and declaration of the representatives of the members of the BAC, the bidding process complied with Republic Act No. 9184 and other pertinent rules and regulations, laws;

**WHEREAS**, if there are documents required the same shall submitted to the Sangguniang Panlungsod;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, authorizing the **Hon. City Mayor Atty. Jaime R. Fresnedi** to enter into and sign the contract in behalf of the City Government of Muntinlupa with **Metrowaste Solid Management Corporation** for the garbage collection and disposal services from **March 1, 2016 to December 31, 2016 ONE** Hundred Ninety Four Million, Nine Hundred Ten Thousand Pesos (Php194,910,000.00) For A Period Of Eight (8) Months Which Amount Shall Be Taken From The 2016 Executive Budget.
