WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and":

(I)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on April 15, 2016 at Lovely St., Purok 4, Barangay Cupang, City of Muntinlupa a fire totally destroyed houses and affected families;

WHEREAS, the owner of the houses, renters, and sharers/boarders were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in a state of calamity;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 7th Sangguniang Panlungsod, to declare the area affected by the fre/conflagration on April 15, 2016 at Lovely St., Purok 4, Barangay Cupang, City of Muntiniupa as in a State of Calamity.

ADOPTED, by the 7th Sangguniang Panlungsod of Muntinlupa this 19th day of April 2016, on its 20th Special Session.
