ORDINANCE NO. 17-043

AN ORDINANCE GRANTING FINANCIAL AND RELIEF ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF POLA, PROVINCE OF ORIENTAL MINDORO WHICH WAS DEVASTED BY TYPHOON NINA AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (PhP500,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER THE 5% MUNTINLUPA CITY DISASTER AND RISK REDUCTION MANAGEMENT FUND (MCDRRMF) TO AID THEIR RECOVERY AND REHABILITATION PROGRAMS.

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or An Act amending Section 324(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that, "a portion of Calamity Fund may be authorized to be used by the LGU concerned to provide financial

WHEREAS, the Municipality of Pola, Province of Oriental Mindoro have been hit by recent typhoon Nina and the City Government of Muntinlupa aims to extend financial and relief assistance to the abovementioned Municipality;

WHEREAS, the Province of Oriental Mindoro by virtue of Resolution No. 2016-134 is respectfully requesting Hon. City Mayor Atty. Jaime R. Fresnedi and the City Government of Muntinlupa to provide and extend financial and relief assistance to aid in their recovery and rehabilitation in the aftermath of the aforesaid typhoon;

WHEREAS, there is an available fund from the 2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF) of the City Government of Muntinlupa to extend and provide assistance to Municipality of Pola, Province of Oriental Mindoro;

WHEREAS, consequent to the grant of assistance to the Municipality of Pola, Province of Oriental Mindoro, the City Government of Muntinlupa will be required to participate in the Post Damage Assessment Needs Analysis (PDANA) for the alignment of financial or relief assistance;

NOW THEREFOR, BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panglungsod of Muntinlupa, to grant financial and relief assistance to the Municipality of Pola, Province of Oriental Mindoro which was devastated by Typhoon Nina in amounting to Five Hundred Thousand Pesos (Php 500,000.00) which amount shall be taken from the 2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF) to aid their recovery and rehabilitation programs be approved.

RESOLVED FURTHER, that the release of the financial grant shall be subject to the presentation of a Resolution from the Sangguniang Panlalawigan of Oriental Mindoro and the Sangguniang Bayan of Pola declaring that their local government unit as in State of Calamity.

ENACTED, by 8th Sangguniang Panlungsod of Muntinlupa, this 9th day of January 2017, on its 21st Regular Session.
