**ORDINANCE NO. 17-055**

**AN ORDINANCE GRANTING FINANCIAL AND RELIEF ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF BATO, PROVINCE OF CATANDUANES WHICH WAS DEVASTATED BY TYPHOON NINA AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (PhP500,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER THE 5% MUNTINLUPA CITY DISASTER AND RISK REDUCTION MANAGEMENT FUND (MCDRRMF) TO AID THEIR RECOVERY AND REHABILITATION PROGRAMS.**

**WHEREAS**, Rule 18, Section 2, of the Implementing Rules and Regulations of Republic Act No. 10121, provides that, **“for a Quick Response Fund (QRF) intends for “relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemics, or complex emergencies, may be normalized as quickly as possible”;**

**WHEREAS**, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or An Act amending Section 324(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that, **“a portion of Calamity Fund may be authorized to be used by the LGU concerned to provide financial assistance to other LGUs”;**

**WHEREAS**, the Province of Catanduanes was declared by the National Risk Reduction Disaster Management Council as one of the badly hit provinces where damage to properties is at its highest;

**WHEREAS**, there is an available fund from the **2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** of the City Government of Muntinlupa to extend and provide assistance to **Municipality of Bato, Province of Catanduanes;**

WHEREAS, consequent to the grant of assistance to the **Municipality of Bato, Province of Catanduanes**, the City Government of Muntinlupa will be required to participate in the **Post Damage Assessment Needs Analysis (PDANA)** for the alignment of financial or relief assistance;

NOW THEREFOR, BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the **8<sup>th</sup> Sangguniang Panglungsod of Muntinlupa**, to grant financial and relief assistance to the **Municipality of Bato, Province of Catanduanes** which was devastated by **Typhoon Nina** amounting to **Five Hundred Thousand Pesos (Php 500,000.00)** which amount shall be taken from the **2017 Executive Budget** under the **5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** to aid their recovery and rehabilitation programs be approved.

PROVIDED FURTHER, that the release of the **Five Hundred Thousand Pesos (Php500,000.00)** financial grant shall be only upon presentation of a council resolution declaring the **Municipality of Bato**, as in a state of calamity;

RESOLVED FURTHER, that the release of the financial grant shall be subject to the presentation of a Resolution from the **Sangguniang Panlalawigan of Catanduanes** and the **Sangguniang Bayan of Bato** declaring that their local government unit **as in State of Calamity**.

ENACTED, by **8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, this **30<sup>th</sup>** day of **January 2017**, on its **24<sup>th</sup> Regular Session**.






