ORDINANCE NO. 17-056

AN ORDINANCE GRANTING FINANCIAL AND RELIEF ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF TINAMBAC, PROVINCE OF CAMARINES SUR WHICH WAS DEVASTED BY TYPHOON NINA AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (PhP500,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER THE 5% MUNTINLUPA CITY DISASTER AND RISK REDUCTION MANAGEMENT FUND (MCDRRMF) TO AID THEIR RECOVERY AND REHABILITATION PROGRAMS.

WHEREAS, Rule 18, Section 2, of the Implementing Rules and Regulations of Republic Act No. 10121, provides that, "*for a Quick Response Fund (QRF) intends for "relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemics, or complex emergencies, may be normalized as quickly as possible"*";

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or An Act amending Section 324(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that, "*a portion of Calamity Fund may be authorized to be used by the LGU concerned to provide financial assistance to other LGUs"*";

WHEREAS, the Province of Camarines Sur was declared by the National Risk Reduction Disaster Management Council as one of the badly hit provinces where damage to properties is at its highest;

WHEREAS, the *Municipality of Tinambac, Province of Camarines Sur* by virtue of **Resolution No. 16-155** is respectfully requesting **Hon. City Mayor Atty. Jaime R. Fresnedi** and the City Government of Muntinlupa to provide and extend financial and relief assistance to aid in their recovery and rehabilitation in the aftermath of the aforesaid typhoon;

WHEREAS, there is an available fund from the **2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** of the City Government of Muntinlupa to extend and provide assistance to **Municipality of Tinambac, Province of Camarines Sur**,

WHEREAS, consequent to the grant of assistance to the **Municipality of Tinambac, Province of Camarines Sur**, the City Government of Muntinlupa will be required to participate in the **Post Damage Assessment Needs Analysis (PDANA)** for the alignment of financial or relief assistance;

NOW THEREFOR, BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the **8th Sangguniang Panglungsod of Muntinlupa**, to grant financial and relief assistance to the **Municipality of Tinambac, Province of Camarines Sur** which was devastated by **Typhoon Nina** amounting to **Five Hundred Thousand Pesos (Php 500,000.00)** which amount shall be taken from the **2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** to aid their recovery and rehabilitation programs be approved.

RESOLVED FURTHER, that the release of the financial grant shall be subject to the presentation of a Resolution from the **Sangguniang Panlalawigan of Camarines Sur** and the **Sangguniang Bayan of Tinambac** declaring that their local government unit **as in State of Calamity**.

ENACTED, by **8th Sangguniang Panlungsod of Muntinlupa**, this **30th** day of **January 2017**, on its **24th Regular Session**.






