ORDINANCE NO. 17-059

AN ORDINANCE GRANTING FINANCIAL AND RELIEF ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF POLANGUI, PROVINCE OF ALBAY WHICH WAS DEVASTED BY TYPHOON NINA AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (Php500,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER THE 5% MUNTINLUPA CITY DISASTER AND RISK REDUCTION MANAGEMENT FUND (MCDRRMF) TO AID THEIR RECOVERY AND REHABILITATION PROGRAMS.

WHEREAS, Rule 18, Section 2, of the Implementing Rules and Regulations of Republic Act No. 10121, provides that, "*for a Quick Response Fund (QRF) intends for "relief and recovery programs in order that the situation and living conditions of people in communities or areas stricken by disaster calamities, epidemics, or complex emergencies, may be normalized as quickly as possible"*";

WHEREAS, Section 5(b.2) of the Rules and Regulations Implementing Republic Act No. 8185 or An Act amending Section 324(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates that, "*a portion of Calamity Fund may be authorized to be used by the LGU concerned to provide financial assistance to other LGUs"*";

WHEREAS, the Province of Albay was declared by the National Risk Reduction Disaster Management Council as one of the badly hit provinces where damage to properties is at its highest;

WHEREAS, one of the Municipalities of Albay is Polangui where, through, the intercession of their Congressman, sought the help of the City of Muntinlupa to aid in its recovery and rehabilitation;

WHEREAS, there is an available fund from the **2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** of the City Government of Muntinlupa to extend and provide assistance to **Municipality of Polangui, Province of Albay**;

WHEREAS, consequent to the grant of assistance to the **Municipality of Polangui, Province of Albay**, the City Government of Muntinlupa will be required to participate in the **Post Damage Assessment Needs Analysis (PDANA)** for the alignment of financial or relief assistance;

NOW THEREFOR, BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the **8th Sangguniang Panglungsod of Muntinlupa**, to grant financial and relief assistance to the **Municipality of Polangui, Province of Albay** which was devastated by **Typhoon Nina** amounting to **Five Hundred Thousand Pesos (Php 500,000.00)** which amount shall be taken from the **2017 Executive Budget under the 5% Muntinlupa City Disaster Risk Reduction and Management Fund (MCDRRMF)** to aid their recovery and rehabilitation programs be approved. **PROVIDED FURTHER**, that the release of the **Five Hundred Thousand Pesos (Php500,000.00)** financial grant shall be only upon presentation of a council resolution declaring the **Municipality of Bato**, as in a state of calamity;

RESOLVED FURTHER, that the release of the financial grant shall be subject to the presentation of a Resolution from the **Sangguniang Panlalawigan of Albay** and the **Sangguniang Bayan of Polangui** declaring that their local government unit **as in State of Calamity**.

ENACTED, by **8th Sangguniang Panlungsod of Muntinlupa**, this **30th** day of **January 2017**, on its **24th Regular Session**.
