#### ORDINANCE NO. 17-074

AN ORDINANCE REQUIRING ALL CINEMA OWNERS/OPERATORS OPERATING WITHIN THE CITY OF MUNTINLUPA TO INCREASE THE PRICE OF THEIR MOVIE TICKETS BY ONE PESO (PHP1.00) COVERING THE PERIOD FROM APRIL 1, 2017 TO MARCH 31, 2018 AS CONTRIBUTION TO SUPPORT THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE SENIOR CITIZENS OF MUNTINLUPA CITY.

WHEREAS, Republic Act 7432 aims to establish mechanisms whereby the contribution of the senior citizens, are maximized:

> whereby senior 1. "To adopt measures citizens are assisted and appreciated by the community as a whole; and

> 2. To establish a program beneficial to the senior citizens, their families and the rest of the community that they serve;"

WHEREAS, a letter dated 6th day of January 2017, was sent by Mrs. Dominga Carolina F. Chavez, Acting Head of OSCA, requesting the Sangguniang Panlungsod for the continuation or partnership with the cinema owners/operators of our city through the one-peso share of their ticket sales to fund the programs and projects of senior citizens by passing another ordinance that will extend the period coverage of the attached Ordinance No. 15-149;

WHEREAS, on 15<sup>th</sup> day of December 2016, the 7<sup>th</sup> Sangguniang Panlungsod of Muntinlupa enacted Ordinance No. 15-149, "an ordinance requiring all cinema owners/operators operating within the City of Muntinlupa to increase the price of their movie tickets by One Peso (Php1.00) covering the period from December 1, 2015, to November 30, 2016 as contribution to support the programs and projects of the Office for Senior Citizens within the City of Muntinlupa."

WHEREAS, although the Office for Senior Citizens Affairs (OSCA) have budget rallocated as listed/sited on their Annual Investment Program (AIP) there is still a need for additional funds to support other activities, programs and projects that may come which is not listed on their AIP;

WHEREAS, the Office for Senior Citizens Affairs (OSCA) have their own Trust Fund Account for this purpose;

NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by 8th Sangguniang Panlungsod in Session Assembled that:

SECTION 1. Title - This ordinance shall be known as the "an ordinance requiring all cinema owners/operators operating within the City of Muntinlupa to increase the price of their movie tickets by One Peso (Php1.00) covering the period from April 1, 2017 to March 31, 2018 as contribution to support the programs, projects and activities of the Senior Citizens of Muntinlupa City."

SECTION 2. Coverage - All cinemas operating within the City of Muntinlupa are hereby required to increase their cinema admission price by One Peso (Php1.00), covering the period from April 1, 2017 to March 31, 2018.

SECTION 3. Remittance - the remittance shall be collected by the City Treasurer's Office and the check shall be under the Name of the City Government of Muntinlupa-OSCA, with Land Bank Account No. 0392-1030-82.

The Cinema Owners/Operators shall be remitted on a monthly basis simultaneous with the payment of their amusement tax.

SECTION 4. Reporting Period - The Treasurer's Office shall within ten (10) days from the receipt of all the remittances, shall inform the City Council in writing as to the exact amount of the said received from the cinema owners/operators.

**SECTION 5.** Copy of this Ordinance shall be given to **all cinemas** operating within the city for their **information and compliance**.

**SECTION 6**. Copy of this ordinance **shall be posted** to every **cashier's booth** of the cinemas operating within the city to inform the moviegoers about the contents of the same.

**SECTION 7.** The City Treasurer's Office shall give notices to those cinemas who will not comply with this Ordinance.

**SECTION 8. Efectivity Clause** -This ordinance shall take effect upon its approval and only within the **covered period**.
