WHEREAS, Sec. 458 (5) (X) of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that "Subject to the availability of funds and to existing laws, rules and regulations, establish and provide for the operation of vocational and technical schools and similar post-secondary institutions and, with the approval of the Department of Education Culture and Sports, and subject to existing law on tuition fees, fix and collect reasonable fees and other educational institutions supported by the city government;

WHEREAS, the City Government of Muntinlupa aims to develop scientific, technological and vocational efficiency among its constituents through an institution of learning conformably with the policies, standards and guidelines under **Commission on Higher Education (CHED)** Memorandum Order No. 32, Series of 2006;

WHEREAS, the City in adherence to the avowed mandate of the Constitution of the Philippines and the Local Government Code has declared a policy to realign the educational system of the City toward the desired accelerated national economic growth, as well as fine tune with the fast changing technological development in the global environment;

Fresnedi** to enter into any and all agreements, execute any and all documents, and do any all acts and things as he may deem just and proper to effectuate the creation of **Colegio de Muntinlupa** for the best interest of the City and its constituents.

SECTION 1. Charter. This Ordinance shall be known as the **CHARTER** of the technological college of the City of Muntinlupa to be known as **Colegio de Muntinlupa** and shall be situated in Barangay Sucat, Muntinlupa City.

SECTION 2. Objectives of the Colegio de Muntinlupa. The **Colegio de Muntinlupa** shall primarily provide higher and globally competitive technological, professional and vocational instruction and training in, such as but not limited to, architecture, engineering, sciences, fisheries, trades and technology, as well as short-term technical or vocational courses, as the Board of Trustees may deem necessary to meet the demands of an emerging industrial society and shall promote researches in the exploitation and conservation of the natural resources, and other scientific and technological fields, as well as maintenance of ecological balance in the City.

SECTION 3. Admission to the Colegio de Muntinlupa. Every deserving and qualified student shall not be denied admission to the **Colegio de Muntinlupa** by reason of age, sex, nationality, ethnic consideration, religious belief, or political affiliation.

SECTION 1. Charter. This Ordinance shall be known as the **CHARTER** of the technological college of the City of Muntinlupa to be known as **Colegio de Muntinlupa** and shall be situated in Barangay Sucat, Muntinlupa City.

SECTION 2. Objectives of the Colegio de Muntinlupa. The *Colegio de Muntinlupa* shall primarily provide higher and globally competitive technological, professional and vocational instruction and training in, such as but not limited to, architecture, engineering, sciences, fisheries, trades and technology, as well as short-term technical or vocational courses, as the Board of Trustees may deem necessary to meet the demands of an emerging industrial society and shall promote researches in the exploitation and conservation of the natural resources, and other scientific and technological fields, as well as maintenance of ecological balance in the City.

SECTION 4. Colegio de Muntinlupa as body corporate. The *Colegio de Muntinlupa* constitutes a body corporate and as such is endowed with the attributes of perpetual succession of a corporation and possessed with such powers which pertain to a college to be exercised in conformity with the provisions its Charter. The *Colegio de Muntinlupa* shall have the following corporate powers:

- a) To have a continuous succession in its corporate name;
- b) To have and use a corporate seal;
- c) To exercise such powers as are granted by the Sangguniang Panlungsod of Muntinlupa, subject to the limitations provided in this ordinance and other pertinent laws.

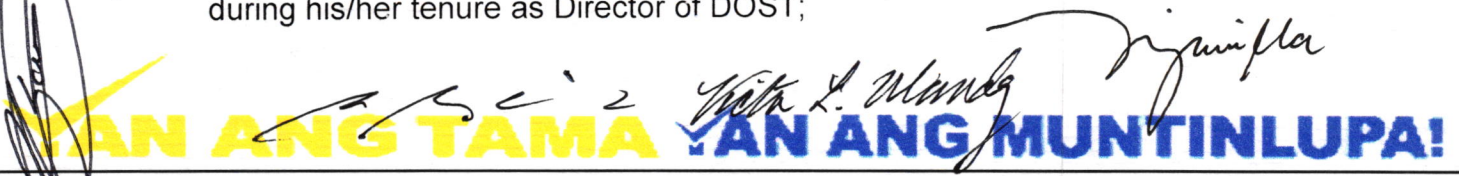
SECTION 5. Composition of The Board of Trustees - The governing body and corporate powers of the *Colegio de Muntinlupa* shall be vested in and exercised by the Board of Trustees composed of the following:

- 1) The City Mayor who shall automatically be the Chairperson of the Board of Trustees;
- 2) He will be the Presiding Officer every meeting of the Board of Trustees;
- 3) The President/Administrator of the *Colegio de Muntinlupa* shall Act as the Presiding Officer of the Board of Trustees in the absence of the Chairperson;
- 4) The Chairperson of the Sanggunian Committee on Education;
- 5) The City Budget Officer (ex-officio) with no voting rights;
- 6) The Regional Director for the Department of Science and Technology (DOST);
- 7) The President of the Faculty Association;
- 8) The President /representative of an accredited business or industry;
- 9) The President of the Supreme Student Council/Government;
- 10) The President of Alumni Association (to be filled-up later);

SECTION 6. Board Secretary. The Board of Trustees shall have a Board Secretary who shall be appointed by the Chairperson and whose term of Office is co-terminus with the Chairperson. He /she shall likewise serve as the Execom Secretary.

SECTION 7. Term of Office. The Members of the Board of Trustees shall have the following term of office:

- 7.1 **The Chairperson** – during his/her term as City Mayor;
- 7.2 **The President/Administrator** – for a term of four (4) years, subject to reappointment;
- 7.3 **The Chairperson**, Sanggunian Committee on Education during his/her term of office as Councilor;
- 7.4 The City Budget Officer for a term of four (4) years.
- 7.5 The Director of the Department of Science and Technology (DOST) during his/her tenure as Director of DOST;

7.6 The President/representative of an accredited business or industry shall serve for a term of two (2) years. .

7.7 The President of the Supreme Student Council/Government shall serve during his/her term of office;

7.8 The President/representative of the faculty shall serve during his/her term of office.

7.9 The President of the Alumni Association shall serve during his/her term of office.

SECTION 8. Vacancies in the Board. In case of vacancy in the Board of Trustees by reason of resignation, removal from office, death or any other incapacity of one or more of its members, such vacancy shall be filled up by appointment by the Chairperson.

SECTION 9. Compensation- The members of the Board of Trustees/Execom shall serve without compensation except for reasonable allowances or per diem as may be authorized by the Board of Trustees.

SECTION 10. Quorum. A quorum of the Board of Trustees shall consist of majority of all the members of the Board. All processes against the Board of Trustees shall be served on the President or Secretary thereof.

SECTION 11. Allowances of the Board in Meetings. The Members of the Board of Trustees shall be entitled to a reasonable allowance of at least Five Thousand Pesos (P5,000.00) per meeting actually attended, provided, that they shall be reimbursed for actual and necessary expenses incurred in attendance of meetings and other official business authorized by resolution of the Board.

SECTION 12. Additional Powers and Duties of the Board. The Board of Trustees, in addition to its general powers of administration and the exercise of all the powers of a corporation as provided in Batas Pambansa Blg. 68 otherwise known as the Corporation Code of the Philippines, in suppletory application, shall have the following powers and duties:

12.1 To receive and appropriate for the purpose specified by law such sums as may be provided for the support of the *Colegio de Muntinlupa*;

12.2 To confer degrees upon successful candidates for graduation. It may also confer honorary degrees upon persons in recognition of learning, statesmanship or eminence in any of the fields of specialization of the Colleges, or in recognition of public service, provided, that such degrees shall not be conferred in consideration of or to reciprocate some personal favor;

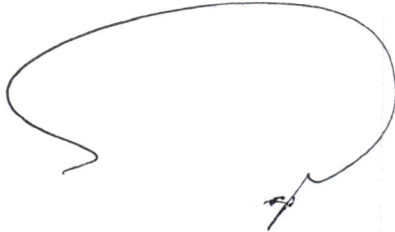

12.3 To authorize the President/Administrator of the *Colegio de Muntinlupa* to award proficiency certificates or diplomas to students who have completed non-degree courses;

12.4 To organize academic units and courses as may be necessary to meet the economic, technological, and social needs of the City Government;

12.5 To confirm the appointment by the City Mayor of academic and administrative officials, faculty and employees of the *Colegio de Muntinlupa*, to fix their compensations, hours of service, and to perform such other duties and conditions as it may deem proper; to grant to them, in its discretion, leaves of absences under such regulations as it may promulgate, any provisions of existing laws to the contrary notwithstanding; and to remove them for cause after an investigation and hearing.

12.6 To approve the curricula and rules of discipline drawn by the College Council as hereinafter provided;

12.7 To fix tuition fees, matriculation fees, graduation fees, laboratory fees, and such other fees and charges;

12.8 To provide fellowships for qualified faculty members; and to provide scholarships for deserving students;

12.9 To prescribe rules for its own governance and to enact for the government of the *Colegio de Muntinlupa* such rules and regulations, not contrary to law, as may be necessary to carry out the purpose and functions of the *Colegio de Muntinlupa*;

12.10 To receive in trust legacies, gifts, and donations of real and personal property of all kinds, to administer the same for the benefit of the *Colegio de Muntinlupa*, or of any department thereof, or for aid to any student or students, in accordance with the directions and instructions of the donor, and in default thereof, in such manners as the Board of Trustees may in its discretion determine.

12.11 To import duty free commodities for educational purposes as an exemption to existing laws;

12.12 To authorize the *Colegio de Muntinlupa* to undertake construction and/or repair of its building, machinery and equipment and other facilities subject to existing laws, rules and regulations.

12.13 To provide vocational training to adult citizens and out-of-school youths;

12.14 To acquire sites or campuses and to provide facilities and improvements as may be necessary.

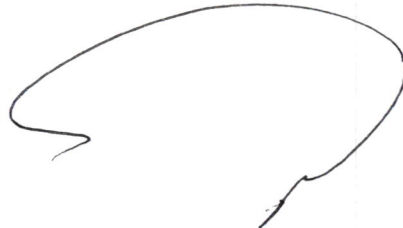

12.15 To promulgate policies in accordance with the declared State policies on higher education as well as the policies, standard and thrust of the CHED, R.A. 722, and other pertinent laws.

12.16 To develop academic arrangement and linkages for institutional capability building with appropriate institutions and agencies, both public and private, local and foreign.

12.17 To institutionalize research and extension programs

12.18 To appoint the member of the Search Committee who will be tasked with the search of the College Administrator

12.19 To nominate the President/Administrator of the Colegio de Muntinlupa, for appointment by the City Mayor, upon recommendation of the search committee.

12.20 To invite representatives from other government or private entities or resource person(s)

SECTION 13. Detailed Progress Report. On or before the fifteenth day of the third month after the opening of regular classes each year and every quarter thereafter, the Board of Trustees shall file with the Office of the Mayor a detailed report on the progress, conditions and needs of the *Colegio de Muntinlupa*.

SECTION 14. Board of Trustees. The regular meetings of the Board of Trustees shall be held at least once a month at the *Colegio de Muntinlupa* or any other place in Muntinlupa City

SECTION 15. Board of Trustees Special Meetings. The special meetings of the Board shall be at the *Colegio de Muntinlupa* or any other place in Muntinlupa City upon call of the Chairperson or majority of the Board of Trustees members.

SECTION 16. Executive Committee - The Executive Committee, hereinafter referred to as the Execom, is hereby created for the purpose of carrying out and exercising the regular functions and powers, which may be lawfully delegated, of the Board of Trustees and composed of the following:

16.1 The President/Administrator of the *Colegio de Muntinlupa* who shall be the Presiding Officer at every meeting of the Execom.

16.2 The Chairperson of the Committee on Education of the Sangguniang Panlungsod;

16.3 The Faculty Representative of the University;

SECTION 17. Execom Acts and Resolutions. All acts and resolutions approved by the Exe-Com shall be ratified by the Board of Trustees. Important matters affecting the administrative and/or academic affairs of the *Colegio de Muntinlupa* shall be reported to the Board of Trustees thru the Chairperson.

SECTION 18. Execom Meetings.- Execom meetings shall be held at the *Colegio de Muntinlupa* or any other place in Muntinlupa City, once every week, provided it shall not exceed four (4) times a month.

The President/Administrator and other members of the Execom shall be entitled to P1,000.00 allowance in every actual meeting attended.

SECTION 19. Notices. Notices of the time and place of the meetings of the Execom shall be given personally or by mail, at least 3 days before the dates set for such meeting.

SECTION 20. Quorum. A quorum for any meeting of the Execom shall consist of the majority of the members and a majority of such quorum may decide any question raised in the meeting.

SECTION 21. Order of Business. The Order of Business of the meetings of the

Board of Trustees and Execom shall be as follows:

- 21.1 Roll Call;
- 21.2 Call to Order;
- 21.3 Approval of the Minutes of the Previous Meetings;
- 21.4 Ratification of All Acts and Resolutions Approved by the Ex-Com (**Only for Board of Trustees Meetings);
- 21.5 New Business;
- 21.6 Other Matters

SECTION 22. Voting. Each Board of Trustees/Execom shall be entitled to one (1) vote and no proxy is allowed.

SECTION 23. College Council. There shall be a College Council with the President/Administrator as Chairperson and all academic staff with a rank not lower than Deans or Program Chairs and heads of different units or offices as members. The Council shall have the power to prescribe/recommend the curricula and rules of discipline, subject to the approval of the Board of Trustees. It shall fix the requirements for admission to the *Colegio de Muntinlupa*, as well as for graduation and conferment of the degrees subject to review by the Board of Trustees. The Council alone shall have the power to recommend students or others to be recipients of degrees or certificates. The Council, through its duly authorized committee, or the President/Administrator of the *Colegio de Muntinlupa* shall have disciplinary power over the students within the limits prescribed by the rules of discipline, as approved by the Board of Trustees.

SECTION 24. Faculty. The body of instructors and professors of the *Colegio de Muntinlupa* shall constitute the faculty of the *Colegio de Muntinlupa*. All other appointments for the position at the *Colegio de Muntinlupa* must conform to the qualifications and standards prescribed by the Civil Service Commissions (CSC) and Commission on Higher Education (CHED).

SECTION 25. Non-Teaching Personnel. The non-teaching personnel shall be composed of *Colegio de Muntinlupa* employees performing non-teaching functions.

SECTION 26. Ex-Officio Treasurer. The City Treasurer shall be the ex-officio treasurer of the *Colegio de Muntinlupa* and all accounts and expenses therefore shall be audited by the Commission on Audit or its duly authorized representative.

SECTION 27. Apparatus, equipment and supplies, detail of personnel. The Department Heads of the City Government are hereby authorized to purchase, upon such request of the City Mayor and President/Administrator of the *Colegio de Muntinlupa*, apparatus, equipment or supplies as may be needed by the *Colegio de Muntinlupa* and to detail employees for duty therein, when in the judgment of the Department Head such employees can be detailed without serious detriment to the public service. Employees so detailed shall perform such duties as required under such detail and the time so employed shall be counted as part of their regular official service.

SECTION 28. Students. The *Colegio de Muntinlupa* shall give preference in the admission of students to bona fide residents of Muntinlupa, subject to the qualifications/rules of admissions as may be approved by the Board of Trustees.

Non-residents of Muntinlupa may avail of special programs in the *Colegio de Muntinlupa* subject to qualifications/rules of admissions as may be promulgated by the board of trustees from time to time.

SECTION 29. Site of the Colegio de Muntinlupa. The parcel of land belonging to the City Government located at **Barangay Sucat, Muntinlupa City** covered by **Transfer Certificate of Title No. 014-2016001007** consisting of Sixteen Thousand Two Hundred Fifteen (16,215) Square Meters more or less is hereby declared to be the future site for the establishment of "*Colegio de Muntinlupa*". Provided, that should the *Colegio de Muntinlupa* cease to exist or be abolished or should such parcel of land aforementioned be no longer needed by the *Colegio de Muntinlupa*, the use thereof shall revert to the City Government.

SECTION 30. Funding. The City Government shall appropriate funds necessary for the operations or the maintenance of the *Colegio de Muntinlupa* annually in the *Executive Budget*. Any or all funds allotted and accruing to the *Colegio de Muntinlupa* shall be put and kept under its name and account, and provided further, that any surplus or unappropriated amount at the end of each year shall remain with the coffers of the *Colegio de Muntinlupa* subject to the existing government accounting and auditing rules and regulations.

SECTION 24. Faculty. The body of instructors and professors of the *Colegio de Muntinlupa* shall constitute the faculty of the *Colegio de Muntinlupa*. The parcel of land belonging to the City Government located at **Barangay Sucat, Muntinlupa City** covered by **Transfer Certificate of Title No. 014-2016001007** consisting of Sixteen Thousand Two Hundred Fifteen (16,215) Square Meters more or less is hereby declared to be the future site for the establishment of "*Colegio de Muntinlupa*". Provided, that should the *Colegio de Muntinlupa* cease to exist or be abolished or should such parcel of land aforementioned be no longer needed by the *Colegio de Muntinlupa*, the use thereof shall revert to the City Government.

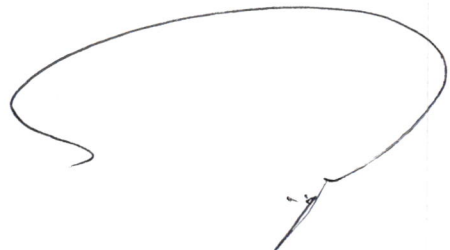

SECTION 31. Position Classifications and Qualification Standards. All positions of the *Colegio de Muntinlupa* shall be governed by a compensation and position classification system and qualification standards approved by the Board of Trustees, Sangguniang Panlungsod and the Civil Service Commission based, on comprehensive job analysis and audit of actual duties and personal responsibilities. The compensation plan shall be comparable with the prevailing compensation plan of the state colleges and universities and shall be subject to periodic review by the City Government, no more than once every three (3) years, without prejudice to yearly merit review or increases based on productivity and efficiency.

SECTION 32. Revenues. As may be permitted by law, the *Colegio de Muntinlupa* is hereby authorized to generate revenue as may be necessary to raise the funds needed for the purpose aforementioned, subject to the approval of the Board of Trustees.

SECTION 33. Reports. The Board of Trustees shall file with the Commission on Higher Education, the Department of Science and Technology, the Office of the City Mayor and the Sangguniang Panlungsod an annual detailed report of the progress, conditions and needs of the *Colegio de Muntinlupa*.

SECTION 34. Separability Clause. If any provision of this ordinance is held invalid or unconstitutional, any other provision not so affected shall continue to be valid and effective.

SECTION 35. Repealing Clause and Amendment. All ordinances, resolutions, and orders contrary or inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.


