AN ORDINANCE APPROVING THE REQUEST OF SAINT CATHERINE LABOURE HOMEOWNERS ASSOCIATION, INC., TO BORROW TEN MILLION PESOS (Php10,000,000.00) TO BE USED AS ADVANCE PAYMENT TO THE HEIRS OF MARGARITA BOMBASE LANDOWNER OF A PARCEL OF LAND LOCATED AT NEARBY PNR BRUGER STREET, BARANGAY PUTATAN, MUNTINLUPA CITY FOR ITS HOUSING PROJECT WHICH AMOUNT SHALL BE TAKEN FROM THE LAND BANKING/SOCIALIZED HOUSING/COMMUNITY MORTGAGE AND OTHER RELATED ACTIVITIES FROM THE 2017 EXECUTIVE BUDGET.

NOW THEREFORE BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panlungsod of Muntinlupa, to grant the request of the Saint Catherine Laboure Homeowners Association, Inc., to borrow Ten Million Pesos (Php10,000,000.00) to be used as advance payment for a parcel of land owned by the heirs of Margarita Bombase located at nearby PNR Bruger Street, Barangay Putatan, Muntinlupa City for its housing project which amount shall be taken from the Land Banking/Socialized Housing/Community Mortgage and other Related Activities from the 2017 Executive Budget.

ORDAINED, FURTHER, that the City Mayor Atty. Jaime R. Fresnedi, be authorized to sign for and in behalf of the City Government the Deed of Assignment (DOA) and witness the Memorandum of Agreement (MOA) between the landowners and the **Saint Catherine Laboure Homeowners Association, Inc.**, that may executed relative to this loan.
