#### **ORDINANCE NO. 17-088**

AN ORDINANCE GRANTING TEN THOUSAND PESOS (PHP10,000.00) TO EVERY HOUSEOWNER (TOTALLY DAMAGED) THREE THOUSAND PESOS (PHP3.000.00) TO HOUSE OWNER (PARTIALLY DAMAGED) FIVE THOUSAND PESOS (PHP5,000.00) TO EVERY HOUSE RENTERS AND SHARERS (TOTALLY DAMAGED), AND OTHER ASSISTANCE TO THE AFFECTED BY THE FIRE QN APRIL 19, 2017 LOCATED AT KM. 25 NAPOCOR ROAD, BARANGAY ALABANG, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER 5% MUNTINLUPA CITY RISK REDUCTION DISASTER AND MANAGEMENT FUND (MCRRDMF). \*\*\*\*

WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(I)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on 24<sup>th</sup> day of April 2017, on its 5<sup>th</sup> Special Session, the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, approved Resolution No. 17-159, "declaring the area affected by the fire on April 19 2017 at Km. 25 Napocor Road, Barangay Alabang, Muntinlupa City, as in a state of calamity".

WHEREAS, on April 19, 2017 at Km. 25 Napocor Road, Barangay Alabang City of Muntinlupa, a fire totally destroyed houses and affected families per attached final report of Social Welfare and Development Office (SWDO) is form part of this Ordinance;

WHEREAS, the owner of the houses and renters, were rendered homeless by reason of the said conflagration;

WHEREAS, the City Government shall also give other assistance and other immediate needs for the affected families;

> WHEREAS, the Social Welfare and Development Office (SWDO) of the City has submitted a certified copy of the list of the homeowners and renters (totally damaged and partially damaged) in coordination with the **Barangay Chairman of** *Alabang, Hon. Ariel J. Gonzaga* and is made an integral part of this ordinance and shall be known as **ANNEX A**;

> WHEREAS, there is an available fund from the 2017 *Executive Budget* under 5% *Muntinlupa Disaster Risk Reduction and Management Fund (LDRRMF)*;

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED,** by the 8<sup>th</sup> Sangguniang Panlungsod duly assembled to grant Ten Thousand Pesos (Php10,000.00) to every house owner (Totally Damaged) Three Thousand Pesos (Php3,000.00) to house owner (Partially Damaged) Five Thousand Pesos (Php5,000.00) to every house renters and sharers (Totally Damaged), and other assistance to the families to the affected by the fire on April 19, 2017, located at Km. **25 Napocor Road, Barangay Alabang, City of Muntinlupa** which amount shall be taken from the 2017 Executive Budget under 5% Muntinlupa City Risk Reduction Disaster and Management Fund (MCRRDMF).

ENACTED, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, this 24<sup>th</sup> day of April 2017, on its 5<sup>th</sup> Special Session.
