**AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO SEVENTY NINE (79) AFFECTED FAMILIES SUBMITTED BY THE URBAN POOR AFFAIRS OFFICE (UPAO) AMOUNTING TO FIVE THOUSAND PESOS (PHP5,000.00) EACH OR A TOTAL AMOUNT OF THREE HUNDRED NINETY FIVE THOUSAND PESOS (PHP395,000.00) WHO WERE AFFECTED BY VIRTUE OF WRIT OF DEMOLITION FACILITATED BY REGIONAL TRIAL COURT (RTC) BRANCH 80 LOCATED AT SOLID MILLS INCORPORATED, BARANGAY SUCAT, MUNTINLUPA CITY WHICH AMOUNT SHALL BE TAKEN FROM 2017 EXECUTIVE BUDGET UNDER THE GENERAL FUND.**

**WHEREAS**, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx":

**WHEREAS**, on March 20-24, 2017, a writ of demolition facilitated by Regional Trial Court (RTC) Branch 80, Muntinlupa was issued against the illegal dwellers and all others occupants of the property owned by Solid Mills Incorporated located at Barangay Sucat, Muntinlupa City;

**WHEREAS**, the housing structures of the Seventy Nine (79) families on the property owned by Solid Mills Incorporated (SMI) located at Barangay Sucat, Muntinlupa City were voluntarily dismantled on March 21, 2017 by virtue of a Writ of Demolition issued by the Regional Trial Court (RTC) Branch 80.

**WHEREAS**, on May 25, 2017, Ms. Alita A. Ramirez OIC, Urban Poor Affairs Office (UPAO) wrote a letter to the Hon. City Mayor, Atty. Jaime R. Fresnedi requesting to grant financial assistance to seventy nine (79) families;

**WHEREAS**, the Urban Poor Affairs Office (UPAO) recommended to grant financial assistance for the affected individuals by the said demolition;

**WHEREAS**, there is a need for the City Government to give financial assistance to the aforesaid individuals;

**WHEREAS**, as certified by the Budget Office there is an available fund from the 2017 Executive Budget under the General Fund;

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED**, by the 8<sup>th</sup> Sangguniang Panlungsod duly assembled to grant financial assistance to Seventy Nine (79) affected families submitted by the Urban Poor Affairs Office (UPAO) amounting to Five Thousand Pesos (Php5,000.00) each or a total amount of Three Hundred Ninety Five Thousand Pesos (Php395,000.00) who were affected by virtue of Writ of Demolition facilitated by Regional Trial Court (RTC) Branch 80 located at Solid Mills Incorporated, Barangay Sucat, Muntinlupa City which amount shall be taken from 2017 Executive Budget under the General Fund.

**ENACTED**, by the 8<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 5<sup>th</sup> day of **June, 2017**, on its 37<sup>th</sup> **Regular Session**.
