ORDINANCE NO. 17-108

AN ORDINANCE MANDATING ALL CINEMA HOUSES, THEATERS, CONCERT HALLS, RECREATIONAL AREAS AND OTHER SIMILAR ESTABLISHMENTS OPERATING IN THE CITY OF MUNTINLUPA TO HAVE A FREE THREE (3) TO FIVE (5) MINUTES AIRTIME OR SCREENING OF VIDEO ABOUT PUBLIC AWARENESS FOR INFORMATION ABOUT CALAMITIES, TRAGEDIES AND DISASTERS.

WHEREAS, there is always an imminent danger of a calamity, tragedy or disaster whether fortuitous or man-made;

WHEREAS, Paragraph iv of Section 456 Article III, Title III of the 1991 Local Government Code states that, *“the Sangguniang Panlungsod as legislative body of the city to adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief assistance for victims during and in aftermath of said disasters or calamities and in their return to productive livelihood following said events”*;

WHEREAS, the best way of preparation for calamity, tragedy, or disaster is through public awareness;

WHEREAS, the public viewing of disaster awareness in cinema, theater, concert halls, recreational areas and other similar establishment would benefit our constituents to prepare themselves in case of calamity, tragedy or disaster happened;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panglungsod of Muntinlupa in Session assembled that:

SECTION 1. This ordinance shall be known as An Ordinance Mandating All Cinema Houses, Theaters, Concert Halls, Recreational Areas and Other Similar Establishments Operating In The City Of Muntinlupa To Have A Free Three (3) to Five (5) minutes Airtime Or Screening Of Video About Public Awareness For Information About Calamities, Tragedies And Disasters;

SECTION 2. Coverage - The coverage of this ordinance are the Cinema Houses, Theatres, Concert Halls, Recreational areas and Other Similar Establishments within the jurisdiction of the City of Muntinlupa;

SECTION 3. It is the policy of the City Government of Muntinlupa:

1. To promote general welfare of its Constituents and protect them from any danger or rent both lives and properties brought about by calamities, disaster, and tragedies;
2. To instill awareness among its constituents about safety precaution in times of calamities, tragedy, and disaster.

SECTION 4. It shall be mandatory for all cinema, houses, theaters, concert halls, recreational areas and other similar establishments operating in the City of Muntinlupa to have Three to five minutes Airtime or screening video about public awareness or information about calamities, tragedies and disasters;

The three (3) to five (5) minutes airtime or screening time shall be done before the start of every show or cinema viewing time or before the main program or performance starts.

SECTION 5. Implementing Office/Department - The City Disaster Risk Reduction Management Office in coordination with the City Public Information Office (PIO) shall be the implementing offices of this ordinance. They shall formulate, make and produce the video to be presented at the cinema houses, theaters, concert halls, recreational areas and other similar establishments.

SECTION 6. Appropriations - The budget for the making and producing of the video about public awareness and safety precaution for calamities, tragedies and disasters shall be taken from the budget of the City Disaster Risk Reduction Management Fund.

SECTION 7. Penalty Clause - in violation of this ordinance the owner/operator of Cinema Houses, Theaters, Concert Halls and Other Similar Establishments shall be penalized as follows:

| 1 st Offence | - Three Thousand Pesos |
| 2 nd Offence | - Five Thousand Pesos |
| 3 rd Offence | - Written notice to comply within Seven (7) days. Non-compliance would mean suspension of operation until compliance. |

SECTION 8. Separability Clause - All ordinances and other resolutions, issuances and orders which are inconsistent with the provisions of this ordinance are hereby repealed and modified accordingly.

SECTION 10. Effectivity Clause - This ordinance shall take effect immediately upon its approval.




