ORDINANCE NO. 17-122

AN ORDINANCE GRANTING ALLOWANCES/INCENTIVES TO ALL PUBLIC SCHOOL TEACHERS FROM DIFFERENT ELEMENTARY AND SECONDARY SCHOOL WITHIN THE JURISDICTION OF THE CITY OF MUNTINLUPA AMOUNTING TO ONE THOUSAND PESOS (PHP1,000.00) EACH PER MONTH AND SHALL BE TAKEN FROM THE 2019 EXECUTIVE BUDGET UNDER GENERAL FUND.

WHEREAS, Section 458 of Republic Act No. 7160, otherwise known as the New Local Government of 1991, states that, "**xxx shall enact ordinances; approve resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx;**

WHEREAS, likewise, Section 458 (viii) of the same code, "**empowers the Sanggunian to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds**";

WHEREAS, "Article 99, 1(xi) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "**when the finances of the city government allow, provide for the additional allowances and other benefits to xxx, public Elementary and High School teachers, and other government officials stationed in or assign to the city.**"

WHEREAS, one of the eight (8) point programs of the Hon. City Mayor Atty. Jaime R. Fresnedi under his administration is Education;

WHEREAS, the public teachers rendered their services and devotion in teaching their students;

**NOW THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED,** by the 8<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** in Session assembled that:

**SECTION 1. Title** – This ordinance shall be known as the ordinance granting of Allowances/incentives To All Public School teachers from different Elementary and Secondary School within the jurisdiction of the City Of Muntinlupa Amounting To One Thousand Pesos (Php1,000.00) Each Per Month, which amount shall Be Taken From The 2018 Executive Budget under the General Fund

**SECTION 2. Coverage** - this ordinance shall cover all public school teachers from the Elementary and Secondary Schools within the jurisdiction of the City of Muntinlupa.

**SECTION 3. Appropriation** - The amount for this allowance/incentives shall be taken from the 2018 Executive Budget under the General Fund.

**SECTION 4. Guidelines** - The Guidelines for this Ordinance shall prepared by the School Division Office (SDO) for its proper implementation.

**SECTION 5.** The total number of Public Teachers from Elementary and Secondary School within the city are as follows:

Number of Public Teachers	Amount of Allowance/Incentives
2,357	Php1,000.00 each

**SECTION 6.** The release of the said fund shall be subject to government accounting and auditing procedure or standards.

**SECTION 7. Effectivity** – This Ordinance shall take effect on **January 1, 2018.**

**ENACTED,** by the 8<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 27<sup>th</sup> day of **November 2017,** on its 57<sup>th</sup> **Regular Session.**
