A RESOLUTION DECLARING THE AREAS AFFECTED BY THE CONFLAGRATION ON FEBRUARY 12, 15, AND 16, 2017 IN #801 VERMILLION ST., AGRO HOMES, BARANGAY PUTATAN, BAGONG SILANG, BARANGAY SUCAT, AND FANTASTIC, SITIO RIZAL, BARANGAY ALABANG, MUNTINLUPA CITY, RESPECTIVELY, AS IN A STATE OF CALAMITY.

WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, **“the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and”**:

(I)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on **February 12, 15, 16, 2017** at 801 Vermillion St., Agro Homes Barangay Putatan, Bagong Silang, Brangay Sucat and Fantastic, Sitio Rizal, Barangay Alabang, Muntinlupa City, a fire totally destroyed houses and affected families;

WHEREAS, the owner of the houses, renters, and sharers/boards were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 8th Sangguniang Panlungsod, to declare the areas affected by the conflagration on **February 12, 15, and 16, 2017** in **#801 Vermillion St., Agro Homes, Barangay Putatan, Bagong Silang, Barangay Sucat, And Fantastic, Sitio Rizal, Barangay Alabang, Muntinlupa City**, respectively, as in a **State of Calamity**.
