RESOLUTION NO. 17-205

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH FRAMECON BUILDERS FOR THE PROJECT ANIMAL IMPOUNDING BUILDING LOCATED AT PACWOOD, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF NINE MILLION THREE HUNDRED FORTY EIGHT THOUSAND SIX HUNDRED FIFTYE EIGHT PESOS AND 81/100 (PHP9,348,658.81) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Animal Impounding Building** located at **Pacwood, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted letter of intent and application for eligibility, and one (1) was found eligible on **June 15, 2017**;

WHEREAS, two (2) bidders were submitted on **June 15, 2017** and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **Framecon Builders** its bid has been found responsive to **Approved Budget for the Contract (ABC)**;

WHEREAS, the amount appropriated for the said project shall be taken from the 2017 Executive Budget;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project **Animal Impounding Building** is amounting to **Nine Million Three Hundred Forty Nine Thousand Six Hundred Ninety Eight Pesos and 81/100 (Php9,349,698.81)**;

WHEREAS, the project was awarded to **Framecon Builders** who being the lowest bidder for the project, **Animal Impounding Building** located at **Pacwood, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **8th Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Framecon Builders** for the project **Animal Impounding Building** located at **Pacwood, Barangay Tunasan, Muntinlupa City** in the amount of **Nine Million Three Hundred Forty Eight Thousand Six Hundred Fifty Eight Pesos and 81/100 (Php9,348,658.81)** which amount shall be taken from the 2017 Executive Budget.

ADOPTED, by the **8th Sangguniang Panlungsod of Muntinlupa** this **7th** day of **August, 2017**, on its **44th Regular Session**.


