RESOLUTION NO. 17-237

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KP GONZALES CONSTRUCTION SUPPLY & TRADING, FOR THE PROJECT CONSTRUCTION OF SEWER TREATMENT PLANT (STP) LOCATED AT SOUTHVILLE MARKET, SOUTHVILLE 3, NBP RESERVATION, BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION SIX HUNDRED SEVENTY FIVE THOUSAND, SIX HUNDRED TWENTY FIVE PESOS AND 41/100 (PHP2,675,625.41) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER 20% COMMUNITY DEVELOPMENT FUND (CDF)-CAPITAL OUTLAY.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, “xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others”;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, “the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Construction Of Sewer Treatment Plant (STP)** located at **Southville Market, Southville 3, NBP Reservation, Barangay Poblacion, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City’s Website and **likewise** posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) contractor/bidder submitted letter of intent and application for eligibility, and was found eligible on August 29, 2017;

WHEREAS, lone bidder was submitted on August 29, 2017 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **KP Gonzales Construction Supply & Trading**, its bid proposal has been found responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the 2017 Executive Budget under the 20% Community Development Fund (CDF)-Capital Outlay;

WHEREAS, the *Approved Budget for the Contract (ABC)* for the project **Construction Of Sewer Treatment Plant (STP)** is amounting to *Two Million Six Hundred Seventy Six Thousand Five Hundred Seventy Pesos and 50/100 (Php2,676,570.50)*;

WHEREAS, the project was awarded to **KP Gonzales Construction Supply & Trading**, being the responsive bidder for the project, **Construction Of Sewer Treatment Plant (STP)** located at Southville Market, Southville 3, NBP Reservation, Barangay Poblacion, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. Fresnedi*, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **KP Gonzales Construction Supply & Trading**, for the project construction of Sewer Treatment Plant (STP) located at Southville Market, Southville 3, NBP Reservation, Barangay Poblacion, Muntinlupa City in the amount of Two Million Six Hundred Seventy Five Thousand, Six Hundred Twenty Five Pesos And 41/100 (Php2,675,625.41) which amount shall be taken from the 2017 Executive Budget under 20% Community Development Fund (CDF)-Capital Outlay (CO).




