A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JOBGRADE GLOBAL TECHNOLOGIES, INC., FOR THE PROJECT REHABILITATION OF CHILD DEVELOPMENT/DAYCARE CENTERS LOCATED AT SOUTHVILLE 3, NBP RESERVATION, BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED SEVENTY FIVE THOUSAND, NINE HUNDRED THIRTY THREE PESOS AND 59/100 (PHP2,875,933.59) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER THE GENDER AND DEVELOPMENT (GAD) FUND.

WHEREAS, lone bidder was submitted on August 24, 2017 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, Jobgrade Global Technologies, Inc., its bid proposal has been found responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the 2017 Executive Budget under the Gender and Development (GAD) Fund;

WHEREAS, the Approved Budget for the Contract (ABC) for the project Rehabilitation Of Child Development/Daycare Centers is amounting to Two Million Eight Hundred Eighty Two Thousand Nine Hundred Ninety Nine Pesos and 44/100 (Php2,882,999.44);

WHEREAS, the project was awarded to Jobgrade Global Technologies, Inc., being the responsive bidder for the project, Rehabilitation Of Child Development/Daycare Centers located at Southville 3, NBP Reservation, Barangay Poblacion, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. Fresnedi,* in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Jobgrade Global Technologies, inc., for the project Rehabilitation Of Child Development/Daycare Centers located at Southville 3, NBP Reservation, Barangay Poblacion, Muntinlupa City in the amount of Two Million Eight Hundred Seventy Five Thousand, Nine Hundred Thirty Three Pesos and 59/100 (Php2,875,933.59) which amount shall be taken from the 2017 Executive Budget under the Gender And Development (GAD) Fund.
