A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH DUMDUMA CONSTRUCTION & TRADING CORPORATION FOR THE PROJECT CONSTRUCTION OF COLLEGE BUILDING LOCATED AT PAMANTASAN NG LUNGSOD NG MUNTINLUPA (PLMUN), NBP COMPOUND, BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF SEVENTY NINE MILLION SIX HUNDRED NINEY THOUSAND, ONE HUNDRED NINETY-SIX PESOS (PHP79,690,196.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the project **College Building** located at **Pamantasan Ng Lungsod Ng Muntinlupa (PLMUN), NBP Compound, Barangay Poblacion, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and likewise posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, two (2) bidder was submitted on September 19, 2017 and one bidder passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **Dumduma Construction & Trading Corporation** its bid proposal has been found to be responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the Infra-Supplemental Budget;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of **College Building**, is amounting to **Php79,699,943.84**;

WHEREAS, the project was awarded to **Dumduma Construction & Trading Corporation** who being the responsive bidder for the project, construction of College Building at Pamantasan ng Lungsod ng Muntinlupa (PLMun), NBP Compound, Barangay Poblacion, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **D.L Cervantes Construction Corporation** for the project construction of **Muntinlupa City Museum** (Phase 2) located at Laguerta, Barangay Tunasan, Muntinlupa City in the amount of **One Hundred Twenty Nine Million Three Hundred Twenty Two Thousand Seven Hundred Thirty Nine Pesos and 18/100 (Php129,322,739.18)** which amount shall be taken from the **Infra-Supplemental Budget**.
