A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH FRAMECON BUILDERS FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE COVERED COURT WITH STAGE LOCATED AT VICTORIA HOMES ELEMENTARY SCHOOL, VICTORIA HOMES SUBDIVISION, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF ELEVEN MILLION FOUR HUNDRED SEVENTY SEVEN THOUSAND TWO HUNDRED SIXTY THREE PESOS AND 98/100 (PHP11,477,263.98) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 LOCAL SCHOOL BOARD BUDGET UNDER LOCAL SCHOOL APPROPRIATION ORDINANCE NO. 02-2017, SERIES OF 2017.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Construction Of Multi-Purpose Covered Court With Stage** located at **Victoria Homes Elementary School, Barangay Tunasan, Muntinlupa City** in a newspaper of general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and likewise posted the same in conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted letter of intent and application for eligibility, and one (1) was found eligible on **October 24, 2017**;

WHEREAS, two (2) bidders were submitted on **October 24, 2017** and passed the preliminary examination of bid,

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **Framecon Builders** its bid was found to be responsive to **Approved Budget for the Contract (ABC)**;

WHEREAS, the amount appropriated for the said project shall be taken from the 2017 Executive Budget under the **2017 Local School Board Budget Under Local School Appropriation Ordinance No. 02-2017, Series Of 2017**;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project *construction of Construction Of Multi-Purpose Covered Court With Stage* amounted to **Php11,477,263.98**;

WHEREAS, the project was awarded to **Framecon Builders** who is the lowest bidder for the project, **construction of Multi-Purpose Covered Court with Stage** located at Victoria Home Elementary School, Barangay Tunasan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **8th Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Framecon Builders** for the project *construction of Multi-Purpose Covered Court with Stage* located at Victoria Homes Elementary School, Victoria Homes Subdivision, Barangay Tunasan, Muntinlupa City in the amount of Eleven Million Four Hundred Seventy Seven Thousand Two Hundred Sixty Three Pesos and 98/100 (PHP11,477,263.98) which amount shall be taken from the 2017 Local School Board Budget under Local School Appropriation Ordinance No. 02-2017, Series Of 2017.
